Upon a motion by Mr. Anders, and seconded by Mr. Quesenberry, the Board voted to withdraw adoption of draft regulations stating that temporary permits will not be issued under the authority of Section 54.1-201.1 of the Code of Virginia and withdrawn authorization to submit an Emergency regulatory package.

The members voting 'yes' were Mr. Anders, Ms. Crawford, Ms. Howard-Seldon, Mr. Minor, Mr. Quesenberry, and Ms. Weaver. There were no negative votes. The motion passed unanimously.

Mr. Ferguson presented a information for the Board's review and Interpretation of discussion dealing with the interpretation of Sections 18 VAC 41-20-100 of the Board for Barbers and Cosmetology Regulations, 18 VAC 41-40-90 of the Wax Technician Regulations, 18 VAC 41-70-100 of the Education Esthetics Regulations, and 18 VAC 41-70-110 of the Esthetics Regulations relating to the qualifications for instructor certification issued by the Board. After discussion, the Board reached a consensus that terms 'post-secondary educational level' or 'postsecondary educational level' be interpreted as an accredited college or university such as J. Sargent Reynolds Community College, College of William and Mary, or Virginia Commonwealth University that is approved or accredited by the Commission on Colleges or by an accrediting agency that is recognized by the U.S. Secretary of Education.

Regulation -Postsecondary

Upon a motion made by Mr. Quesenberry and seconded by Ms. Crawford the Board voted that pertaining to Sections 18 VAC 41-20-100 of the Board for Barbers and Cosmetology Regulations, 18 VAC 41-40-90 of the Wax Technician Regulations, 18 VAC 41-70-100 of the Esthetics Regulations, and 18 VAC 41-70-110 of the Esthetics Regulations terms 'post-secondary educational level' or 'postsecondary educational level' be interpreted as an accredited college or university that is approved or accredited by the Commission on Colleges or by an accrediting agency that is recognized by the U.S. Secretary of Education.

The members voting 'yes' were Mr. Anders, Ms. Crawford, Ms. Howard-Seldon, Mr. Minor, Mr. Quesenberry, and Ms. Weaver. There were no negative votes. The motion passed unanimously.
