He informed the Board that the required public comment period had ended on December 18, 2015, and the Board will be asked to approve the responses to the public comments and adopt the proposed changes to the Regulations before sending them to the Executive Branch for final review.

Regulatory Report

Mr. Melis reported on the January 27, 2016 meeting of the Ad Hoc Committee on Career and Technical Education. Mr. Melis stated that the goal of the Committee has been to re-establish communication with the Virginia Department of Education (DOE) and share the Board's concerns about the public school curricula and reduced program hours. The Committee met with the DOE on January 28, 2016 to express its concerns and propose increasing the program from the present 2-year structure to a 3-year, 840 hour program. The Committee recommended that the Board consider formally requesting that DOE implement the 3-year, 840 hour program.
