Mr. Kirschner reported on the August 5, 2015 meeting between Board staff and Mr. George Wilcox and Mr. Anthony Williams, of the Virginia Department of Education (DOE), at which staff addressed the concerns of the DOE representatives about what steps have been taken and will be taken in the future to improve the examination process for public school students. Mr. Kirschner stated that the concerns of the Board's Ad Hoc Committee for Vo-Tech Training were also addressed and that Board representatives will participate in the DOE's next curriculum review in January 2016.

Reports

Regulatory Review Report

Mr. Kirschner reported that the Barbers and Cosmetologist Regulations and the Esthetic Regulations were approved by the Governor, and that the next phase of the review process would be Public Comment Period beginning in mid-October and a public hearing which has not yet been scheduled. Mr. Kirschner also indicated that the Governor had recommended two revisions to the Regulations, (1) that the regulation related to providing a restroom for customers be adjusted so as not to be a hardship to current businesses; and (2) to narrow the requirements for criminal background checks. The Governor's recommendations will be

Legislative Report

Mr. Melis reported that no legislation impacting the Board was passed by the General Assembly. Legislation that was tabled by the legislature included definitions for cosmetic treatments; an exemption for threading; school definitions; and adding a dermatologist to the Board.
