#### **REPORTS**

Mr. Kirschner reported to the Board on examination scores. Mr. Kirschner informed the Board that the revised barber exam was introduced on December 11, 2017, tailored to the interpretation of the barber scope of practice, resulting in a 25% increase in scores. He also advised the Board that the revised master esthetician exam was introduced on January 11, 2018, but pass rates for that exam are not yet available.

**Examinations** 

Mr. Kirschner reported to the Board on the Barbering Committee Meeting and the Esthetics Apprenticeship Committee Meeting, both of which took place on December 14, 2017.

Barbering and
Esthetics SubCommittee
Meetings

The Barbering Committee has recommended approval of the proposed changes to the Standards of Apprenticeship, including the reduction of the barber apprenticeship from 3,000 to 2,000 hours. The esthetics committee also recommended adopting updates to the standards of apprenticeship as recommended by the Department of Labor and Industry.

Mr. Kirschner reported that, effective January 1, 2018, esthetics instructors may now teach waxing.

Regulatory Report

Mr. Kirschner advised the Board that pending fast-track regulatory action regarding barbering performances was withdrawn at the recommendation of the barber committee and Department of Planning and Budget, as well as in light of pending legislation that will impact the issue.

Mr. Kirschner stated that Tattoo and Body-Piercing Regulations are under review and will be discussed later in the meeting. He advised the Board that a Committee would need to be formed to conduct the review of the regulations prior to the May 2018 Board meeting.

Mr. Melis reported on legislative activity to date. Most notably, two pieces of legislation which appear likely to pass one which would authorize a master barber program, and another which would have impacts to establishments and the following practices: cleansing/shampooing, arranging, dressing, curling.

Legislative Report

Mr. Quesenberry opened the floor for public comment after several individuals arrived late to the meeting and wished to address the Board.

**Public Comment** 

Ms. Meredith Harrison, of American Spirit Institute, addressed the Board on the topic of the transfer of credits for cosmetology students and the requirement that both schools involved in the transfer must be accredited. Ms. Harrison brought

Mr. Kirschner indicated that fast-track regulations had been submitted to address the matter and has since been withdrawn for revision.

He further advised the Board of pending legislative action that may require emergency regulations to create a master barber license category and automatically issue Master Barber licenses to all qualified barbers through grandfathering. Mr. Kirschner advised the Board that a committee would need to be created to draft the emergency regulations, and he asked for volunteers. Mr. R. Jones, Mr. Minor, and Ms. LaPierre agreed to serve on the committee. He further advised that the curriculum hours for a master barber would be 1,500, and the curriculum hours for a barber would be 1,100. Mr. Kirschner further advised that a called Board meeting may be required prior to the May 2018 scheduled meeting.

Mr. Kirschner asked the Board for a motion to accept the changes to the Barbers and Cosmetology Standards of Apprenticeship recommended by the barbering subcommittee. Upon a motion by Mr. R. Jones and seconded by Mr. Minor, the Board voted to accept the recommended changes to the Standards of Apprenticeship.

The members voting 'yes' were Mr. R. Jones, Ms. LaPierre, Ms. Mace, Ms. McCaffrey, Mr. Minor, Mr. Quesenberry, Mr. Roberts, and Ms. Tsamouras. There were no negative votes. The motion passed unanimously.

Mr. Kirschner asked the Board for a motion to accept the final changes to the Esthetician and Master Esthetician Standards of Apprenticeship as
