Mr. Kirschner recommended the Board consider procure a national exam, not limited to the NIC, upon the end of the current examinations vendor's contract. The Board discussed the issue.

Mr. Kirschner reported to the Board that the apprenticeship programs for estheticians and master estheticians have started in the Department of Labor and Industry.

Mr. Kirschner reported to the Board on a meeting in October between himself, Ms. Acosta, and individuals in the Virginia tattoo industry regarding current tattoo and body piercing regulations. Mr. Kirschner recommended that the Board form a tattooing and body piercing regulations committee to review the recommendation that came out of the meeting and make additional recommendations to the Board.

Upon a motion by Ms. Acosta and seconded by Ms. Dang, the Board voted to form a committee to review the tattoo and body piercing regulations.

The members voting 'yes' were Ms. Acosta, Ms. Dang, Mr. Hill, Ms. LaPierre, Mr. Mayes, Mr. Quesenberry, and Mr. Roberts. There were no negative votes. The motion passed unanimously.

Mr. Kirschner reported to the Board on the progress of the Master Barber Regulations and provided an overview of the creation of the Master Barber license. He reported that the proposed regulations are in the Secretary of Commerce's office at this time.

Mr. Kirscher advised the Board that the typographical corrections it had recommended to the Esthetician and Master Esthetician Regulations have been approved and will take effect on January 1, 2019.

Mr. Kirschner directed the Board to his memo, dated November 2, 2018, regarding the regulatory requirement for tuberculocidal disinfectants and a decision by the NIC to not include the term "tuberculocidal" in its publication, "Infection Control Best Practices," which had been provided for the Board's review. After discussion, and upon a motion by Mr. Mayes and seconded by Mr. Hill, the Board voted to remove the term "tuberculocidal" from the regulations, leaving the requirement as "a hospital grade disinfectant solution registered with the EPA."
