REGULATORY ACTION AND BOARD GUIDANCE

Mr. Kirschner presented a report on pending regulatory actions, noting that the revised Tattoo and Body Piercing Regulations remain in the Governor's Office for review. Mr. Kirschner advised the Board that, after approval by the Governor, the revised regulations will be available for a 60-day public comment period before entering the final Board review, during which the Board may address any changes proposed by the Governor and/or by public comment.

Regulatory Report

Mr. Kirschner reported to the Board on a pending fast-track regulatory action to provide an exception to training requirements allowing experience in lieu of substantially equivalent training. The fast-track document is currently under consideration by the Department of Planning and Budget, after which it will proceed through Executive Branch review.

Mr. Kirschner provided information to the Board on the Governor's updates to Executive Order 67, that include permission for the removal of face coverings for treatment to areas of the mouth and nose, including beard services. He advised the Board of a pending budget amendment bill regarding the wearing of face coverings for personal care services, and stated that a called meeting of the Board could result if the legislature rejects the Governor's amendments to Executive Order 67.

NEW BUSINESS

The Board discussed a return to Board committee meetings, including the Standing Committee on Training. After discussion, the Board's consensus was to revisit the topic of committees at the January 11, 2021 meeting.
