Ms. Simonds called the meeting to order at 10:03 a.m. Call to Order

Mr. Benenson moved to approve the minutes from the October 28, 2019 meeting. Ms. Conrad seconded the motion which was unanimously approved by members: Benenson, Conrad, Montano, O'Toole and Simonds.

Approval of Minutes

There was no public comment.

Public Comment

Ms. Nosbisch provided background information on the draft report presented to the Board. The Joint Legislative Audit & Review Commission (JLARC) report on the operations and performance of DPOR, October 2018, contained two recommendations for the Board

which required action by December 31, 2019. Discussion was held on the next steps for the report. Ms. Nosbisch stated that staff would receive input from stakeholders; public comment from professions, as well as, affected public; and use additional research in preparation for the final report due December 31, 2020. Ms. Broz-Vaughan added that the study will be provided to the General Assembly and they will make the determination for continuation licensing/certification programs. taking statutory criteria into consideration.

Mr. O'Toole inquired as whether any licensing/certification programs contained in the report would be taken up in the upcoming General Assembly. Ms. Broz-Vaughan commented that the agency remains objective on these matters, and will provide technical assistance and information as needed.

Mr. O'Toole moved to approve the draft report. Ms. Conrad seconded the motion which was unanimously approved by members: Benenson, Conrad, Montano, O'Toole and Simonds.

Ms. Nosbisch informed the Board that all DPOR boards undergo regulatory review every four years for all board's regulations. The boards can retain, repeal or amend the regulations. This process will be completed by December 31, 2019

Periodic Review

Board members were provided board liaison assignments. Ms. Nosbisch **Board Liaisons** encouraged Board members to attend meetings of their assigned boards. Mr. Montano will be the liaison for boards assigned to former Board member Mr. Goldman.

Ms. Nosbisch inquired as to where members see the Board in five to ten years. Discussion was held on the future of the Board with regards to today's regulatory environment. Ms. Simonds commented that the upcoming year could prove to be a busy one for the Board.

Board Future

The 2020 tentative meeting dates were presented: March 2, June 8, September 21, and December 7. Mr. Montano moved to approve the dates as presented. Mr. O'Toole seconded the motion which was unanimously approved by members: Benenson, Conrad, Montano, O'Toole and Simonds.

Ms. Nosbisch commented that the meeting would be Ms. Simonds last as chair and board member, before she joins the House of Delegates as the Representative of the 94th District. Election of Officers was conducted for the 2019-2020 term. Mr. Montano moved to nominate Ms. Conrad as Chair. There being no further nominations, Ms. Simonds seconded the
