CALL TO ORDER

Mr. Graves called the meeting to order at 10:00 a.m. and asked the Board Members and staff to introduce themselves.

With eight Board Members present at the meeting, a quorum was established.

Mr. Graves read the mission of the Board, which is also the mission of the Department of Health Professions (DHP).

Mr. Graves reminded the Board Members and audience about microphones, computer agenda materials, breaks, sign-in sheets, and attendance for continuing education requirements.

Ms. Tillman Wolf then read the emergency egress instructions.

APPROVAL OF MINUTES

Mr. Graves opened the floor to any edits or corrections regarding the draft minutes for the Board Meeting and Formal Hearing held on April 16, 2024, and the Regulatory Advisory Panel Meeting held on July 10, 2024. The minutes were approved as presented.

ORDERING OF THE AGENDA

Mr. Graves opened the floor to any additional items to add to the agenda.

Upon a *MOTION* by Ms. Barton, properly seconded by Mr. Wray, the Board voted to accept the agenda as presented. The motion carried (8-0).

PUBLIC COMMENT

Mr. Robinson, Virginia Morticians' Association (VMA), provided written public comment thanking Mr. Wray and Ms. Tillman Wolf for their presentations at the VMA Annual Meeting in June 2024.

AGENCY REPORT

Mr. Owens welcomed Board Members and thanked them for their service and contribution to the profession.

Mr. Owens spoke about the successful 2024 General Assembly Session and legislative efforts, including the formal acceptance of the state budget. Mr. Owens clarified that DHP does not receive any funds from the General Assembly, but rather the authority to spend as DHP is a special funded agency deriving funds from licensure fees.

Mr. Owens provided information regarding the transition of DHP management. He reported that Diane Powers, Director of Communications, had retired effective April 1, 2024. Mr. Owens also reported that Lisa Hahn, Chief Operating Officer, retired effective July 1, 2024, and that Jay Douglas, Executive Director for the Board of Nursing, would retire effective September 1, 2024. He stated that he anticipates a seamless transition of these positions.

Mr. Owens reported on staff retention efforts through the study of agency salaries.

Executive Director's Report - Corie E. Tillman Wolf, JD, Executive Director

Welcome and Congratulations

Ms. Tillman Wolf announced Ms. Pagano's retirement effective August 2024, with her last day in the office on July 31, 2024. She welcomed Annette Kelley as the new Deputy Executive Director of the Board.

Board Updates

Ms. Tillman Wolf provided Board updates since the last quarterly meeting, to include mention of the Regulatory Advisory Panel meeting held on June 10, 2024, to discuss recommendations on emergency regulations to implement the declinable preneed funeral guarantee fee established by SB 521, Chapter 247 of the 2024 Acts of Assembly. She noted that a number of trainings were provided by Board members and staff in June 2024 to the Virginia Funeral Directors Association (VFDA) (Slusser) and to the VMA (Wray and Tillman Wolf).

Ms. Tillman Wolf stated that the next meeting of the Board's Examination Committee will be pushed to early 2025 due to the pending amendments to the regulations.

Data Updates

Ms. Tillman Wolf provided an update on the number of Funeral Director and Embalmer-only applications and licenses received and issued since the bifurcation of licenses was implemented in 2021.

International Conference Updates

Ms. Tillman Wolf provided brief updates from the International Conference of Funeral Service Examining Boards. Ms. Tillman Wolf is currently serving on the Bylaws Committee.

Additional Updates - CANA

Ms. Tillman Wolf highlighted recent information from the Cremation Association of North America (CANA) which has new resources available on its website related to natural organic reduction and alkaline

Panel members provided recommendations on draft emergency regulations to effectuate the provisions of SB521, which created a declinable preneed funeral guarantee fee for preneed contracts. Mr. Slusser provided an overview of the areas where the panel members reached consensus on how the declinable preneed funeral guarantee fee would be implemented in practice.

BOARD DISCUSSION AND ACTIONS

Consideration of Recommendations of the Regulatory Advisory Panel

Ms. Barrett presented the recommendations of the Regulatory Advisory Panel that was convened on July 10, 2024. She stated that the Panel discussed and compiled recommendations to the full Board regarding the content of the emergency regulations that are required by SB 521, Chapter 247 of the 2024 Acts of Assembly, which established a declinable preneed funeral guarantee fee.

Adoption of Emergency Regulations and Initiation of a Notice of Intended Regulatory Action (NOIRA) for Preneed Funeral Contracts – Declinable Preneed Funeral Guarantee Fee (SB 521 – Ch. 247 of the 2024 Acts of Assembly) (18VAC65-30-10 et seq.)

Upon a *MOTION* by Mr. Wray, properly seconded by Mr. Hanif, the Board voted to adopt emergency regulations and to initiate a Notice of Intended Regulatory Action to amend 18VAC65-30-10 et seq. related to the declinable preneed funeral guarantee fee and as required by Senate Bill 521, Chapter 247 of the 2024 Acts of Assembly as presented. The motion passed unanimously (8-0).

Mr. Slusser thanked Mr. Saunders, Ms. Barrett, and Ms. Tillman Wolf for their assistance with the Regulatory Advisory Panel meeting.

PRESENTATION

2024 Report – Virginia's Funeral Service Provider Workforce - Barbara Hodgdon, PhD, Deputy Director, Healthcare Workforce Data Center

Dr. Hodgdon provided a summary of the findings of the 2024 Workforce Report for Funeral Service Providers.

Upon a *MOTION* by Ms. Barton, properly seconded by Dr. Hickey, the Board voted to accept the 2024 Workforce Report for Funeral Service Providers as presented. The motion carried unanimously (8-0).

Mr. Hines was nominated for the position of Vice-President. There were no other nominations. The nominations were closed.

Upon a *MOTION* by Ms. Mimms, properly seconded by Mr. Wray, the Board voted to elect Mr. Hines as Vice-President of the Board of Funeral Directors and Embalmers. The motion passed unanimously (8-0).

Mr. Graves opened the floor for nominations for Secretary-Treasurer of the Board of Funeral Directors and Embalmers.

Dr. Hickey was nominated for the position of Secretary-Treasurer. There were no other nominations. The nominations were closed.

Upon a *MOTION* by Mr. Slusser, properly seconded by Ms. Barton, the Board voted to elect Dr. Hickey as Secretary-Treasurer of the Board of Funeral Directors and Embalmers. The motion passed unanimously (8-0).

VIRGINIA ACTS OF ASSEMBLY -- 2024 SESSION

CHAPTER 200

An Act to amend and reenact § 54.1-2807.01 of the Code of Virginia and to amend the Code of Virginia by adding a section numbered 54.1-2807.03, relating to funeral arrangements; disputes between next of kin; proof of next of kin status.

[H 652]

Approved March 28, 2024

Be it enacted by the General Assembly of Virginia:

1. That § 54.1-2807.01 of the Code of Virginia is amended and reenacted and that the Code of Virginia is amended by adding a section numbered 54.1-2807.03 as follows:

§ 54.1-2807.01. When next of kin disagree.

A. In the absence of a designation under § 54.1-2825, when there is a disagreement among a decedent's next of kin concerning the arrangements for his funeral or the disposition of his remains, any of the next of kin may petition the circuit court where the decedent resided at the time of his death to determine which of the next of kin shall have the authority to make arrangements for the decedent's funeral or the disposition of his remains. The court may require notice to and the convening of such of the next of kin as it deems proper.

B. In determining the matter before it, the court shall consider the expressed wishes, if any, of the decedent, the legal and factual relationship between or among the disputing next of kin and between each of the disputing next of kin and the decedent, and any other factor the court considers relevant to determine who should be authorized to make the arrangements for the decedent's funeral or the disposition of his remains.

C. When there is a disagreement among a decedent's next of kin concerning the arrangements for his funeral or the disposition of his remains, at least one of the next of kin shall, within 48 hours of the funeral service establishment receiving the decedent's remains, notify such funeral service establishment of the dispute, at which time the funeral service establishment shall immediately stop making arrangements for the decedent's funeral or for the disposition of the decedent's remains until such time as an agreement is reached by the disputing next of kin or a court of appropriate jurisdiction has ruled on any petition filed by such disputing next of kin.

D. If there is a dispute regarding the identity of any persons who have the right to make arrangements and otherwise be responsible for the decedent's funeral and the disposition of such decedent's remains, a funeral service establishment shall not be liable for refusing to dispose of the decedent's remains or complete the arrangements for the final disposition of such remains until the funeral service establishment receives a court order or written agreement signed by the disputing next of kin that establishes the final disposition of the decedent's remains. If the funeral service establishment retains the decedent's remains for final disposition while any such dispute is pending, the funeral service establishment may embalm or refrigerate and shelter the decedent's body for preservation purposes until the dispute is resolved. Any person or persons adjudged or agreed to have the right to make arrangements and otherwise be responsible for the decedent's funeral and the disposition of the decedent's remains shall be responsible for any costs incurred by the funeral service establishment pursuant to this subsection.

§ 54.1-2807.03. Proof of next of kin status.

A. A funeral service licensee may require that a person claiming next of kin status, in accordance with the definition of next of kin in § 54.1-2800, execute a document affirming that such person is the next of kin. Upon execution of this form, the funeral service licensee is exempt from any liability for allowing such person to proceed with funeral planning for the decedent.

B. A funeral service licensee may, as a part of affirming that such person is next of kin under this section, rely on the decedent's will that names such person as the individual the decedent wishes to serve as next of kin for making funeral and burial arrangements, regardless of whether the will has been probated.

Code of Virginia

Title 54.1. Professions and Occupations

Subtitle III. Professions and Occupations Regulated by Boards within the Department of Health Professions

Chapter 28. Funeral Services

Article 2. Licensure of Funeral Establishments

§ 54.1-2811.1. Handling and storage of human remains

A. Upon taking custody of a dead human body, a funeral service establishment shall maintain such body in a manner that provides complete coverage of the body and that is resistant to leakage or spillage, except during embalming or preparation of an unembalmed body for final disposition; restoration and dressing of a body in preparation for final disposition; and viewing during any visitation and funeral service.

B. If a dead human body is to be stored for more than 48 hours prior to disposition, a funeral services establishment having custody of such body shall ensure that the dead human body is maintained in refrigeration at no more than approximately 40 degrees Fahrenheit or embalmed. A dead human body shall be maintained in refrigeration and shall not be embalmed in the absence of express permission by a next of kin of the deceased or a court order.

C. If a dead human body is to be stored for more than 10 days prior to disposition at a location other than a funeral service establishment, the funeral service establishment shall disclose to the contract buyer the location where the body is to be stored and the method of storage.

D. Funeral services establishments, crematories, or transportation services shall not transport animal remains together with dead human bodies. Further, animal remains shall not be refrigerated in a unit where dead human bodies are being stored.

Code of Virginia

Title 54.1. Professions and Occupations

Subtitle III. Professions and Occupations Regulated by Boards within the Department of Health Professions

Chapter 28. Funeral Services

Article 1. Board of Funeral Directors and Embalmers

§ 54.1-2806. Refusal, suspension, or revocation of license, registration, or courtesy card

- A. As used in this section, "license" shall include any license, registration, or courtesy card issued by the Board.
- B. The Board may refuse to admit a candidate to any examination, refuse to issue a license to any applicant and may suspend a license for a stated period or indefinitely, or revoke any license or censure or reprimand any licensee or place him on probation for such time as it may designate for any of the following causes:
- 1. Conviction of any felony or any crime involving moral turpitude;
- 2. Unprofessional conduct that is likely to defraud or to deceive the public or clients;
- 3. Misrepresentation or fraud in the conduct of the funeral service profession, or in obtaining or renewing a license;
- 4. False or misleading advertising or solicitation;
- 5. Solicitation at-need or any preneed solicitation using in-person communication by the licensee, his agents, assistants or employees; however, general advertising and preneed solicitation, other than in-person communication, shall be allowed;
- 6. Employment by the licensee of persons known as "cappers" or "steerers," or "solicitors," or other such persons to obtain the services of a holder of a license for the practice of funeral service;
- 7. Employment directly or indirectly of any agent, employee or other person, on part or full time, or on a commission, for the purpose of calling upon individuals or institutions by whose influence dead human bodies may be turned over to a particular funeral establishment;
- 8. Direct or indirect payment or offer of payment of a commission to others by the licensee, his agents, or employees for the purpose of securing business;
- 9. Use of alcohol or drugs to the extent that such use renders him unsafe to practice his licensed activity;
- 10. Aiding or abetting an unlicensed person to practice within the funeral service profession;
- 11. Using profane, indecent, or obscene language within the immediate hearing of the family or relatives of a deceased, whose body has not yet been interred or otherwise disposed of;
- 12. Solicitation or acceptance by a licensee of any commission or bonus or rebate in consideration of recommending or causing a dead human body to be disposed of in any crematory, mausoleum, or cemetery;

- 13. Violation of any statute, ordinance, or regulation affecting the handling, custody, care, or transportation of dead human bodies;
- 14. Refusing to surrender promptly the custody of a dead human body upon the express order of the person lawfully entitled to custody;
- 15. Knowingly making any false statement on a certificate of death;
- 16. Violation of any provisions of Chapter 7 (§ 32.1-249 et seq.) of Title 32.1;
- 17. Failure to comply with § 54.1-2812, and to keep on file an itemized statement of funeral expenses in accordance with Board regulations;
- 18. Knowingly disposing of parts of human remains, including viscera, that are received with the body by the funeral establishment, in a manner different from that used for final disposition of the body, unless the persons authorizing the method of final disposition give written permission that the body parts may be disposed of in a manner different from that used to dispose of the body;
- 19. Violating or failing to comply with Federal Trade Commission rules regulating funeral industry practices;
- 20. Violating or cooperating with others to violate any provision of Chapter 1 (§ 54.1-100 et seq.), Chapter 24 (§ 54.1-2400 et seq.), this chapter, or the regulations of the Board of Funeral Directors and Embalmers or the Board of Health;
- 21. Failure to comply with the reporting requirements as set forth in § 54.1-2817 for registered funeral service interns;
- 22. Failure to provide proper and adequate supervision and training instruction to registered funeral service interns as required by regulations of the Board;
- 23. Violating any statute or regulation of the Board regarding the confidentiality of information pertaining to the deceased or the family of the deceased or permitting access to the body in a manner that is contrary to the lawful instructions of the next-of-kin of the deceased;
- 24. Failure to include, as part of the general price list for funeral services, a disclosure statement notifying the next of kin that certain funeral services may be provided off-premises by other funeral service providers;
- 25. Disciplinary action against a license, certificate, or registration issued by another state, the District of Columbia, or territory or possession of the United States;
- 26. Failure to ensure that a dead human body is maintained in refrigeration at no more than approximately 40 degrees Fahrenheit or embalmed if it is to be stored for more than 48 hours prior to disposition. A dead human body shall be maintained in refrigeration and shall not be embalmed in the absence of express permission by a next of kin of the deceased or a court order; and
- 27. Mental or physical incapacity to practice his profession with safety to the public.

Part II. Sale of Preneed Plans

18VAC65-30-50. Solicitation.

A. In accordance with provisions of § 54.1-2806 of the Code of Virginia, a licensee shall not initiate any preneed solicitation using in-person communication by the licensee or his agents, assistants, or employees.

B. After a request to discuss preneed planning is initiated by the contract buyer or interested consumer, any contact and in-person communication shall take place only with a funeral service licensee or a licensed funeral director. Funeral interns shall not engage in preneed planning or sales.



Thanks for speaking with me today. I'm following up in regards to our conversation regarding student embalmings in Virginia. There are Virginia students who are attending fully online mortuary schools that are located in other states. These students need to be able to complete their embalming clinicals in a local Virginia funeral home under the supervision of a Virginia licensee.

As you seek guidance from the Board as to whether these Virginia students can complete their embalming clinicals under the current regulations, below are some things that can be brought to the Board's attention. All ABFSE accredited mortuary schools must adhere to the following criteria in regards to off-campus instruction:

7.2 The following is for off-campus instructional sites which includes instruction for management, funeral directing and embalming clinical. Whenever students receive program credit for work carried out off the main campus, the

following facilities requirements must be in effect:

- 7.2.1 The facility where students receive credit must be licensed by the appropriate authorities;
- 7.2.2 Off-campus instruction must take place in locations which offer adequate learning space for students. In the case of instruction in embalming, the facility must be of sufficient size to allow for satisfactory participation by each student.
- 7.2.3 Inspections of off-campus instructional sites must occur at least once every three years or prior to each use if the use occurs intermittently over a period of several years. Inspections must also occur whenever physical

changes to the facility are reported.

- 7.2.3.a Inspections of off-campus instruction sites must ensure the location has a valid, current license.
- 7.2.3.b Inspections must ensure that off-campus sites are clean and adequate for instructional purposes.
- 7.2.3.c The inspection must ensure that appropriate equipment and protocols (drench shower, eye wash station, SDS and blood borne pathogen program, ventilation system, proper protective equipment, etc.) are in place and functioning.

Some mortuary schools with online programs such as Pierce Mortuary Colleges (Gupton-Jones, Dallas Funeral Service Institution & Mid-America) also require a recent formaldehyde test that meets OSHA guidelines.

I hope this is enough information to share with the Board in hopes that their guidance will allow for Virginia online mortuary students to complete their clinicals with a VA licensee.

Article 1. Board of Funeral Directors and Embalmers

§ 54.1-2805. Engaging in the practice of funeral services or the business of preneed funeral planning or acting as a funeral director or embalmer without a license

A. It shall be unlawful for any person to engage in or hold himself out as engaging in the practice of funeral services or the business of preneed funeral planning, to operate a funeral service establishment, or to act as a funeral director or embalmer or hold himself out as such unless he is licensed by the Board. Engaging in the practice of funeral services, preneed funeral planning, operating a funeral service establishment, or acting as a funeral director or embalmer shall be recognized as that of a health profession.

B. Notwithstanding the provisions of subsection A, a person who is duly enrolled in a mortuary education program in the Commonwealth may assist in embalming while under the immediate supervision of a funeral service licensee or embalmer with an active, unrestricted license issued by the Board, provided that such embalming occurs in a funeral service establishment licensed by the Board and in accordance with regulations promulgated by the Board.

Part III. Requirements for Licensure

18VAC65-20-236. Requirements for students assisting with embalming.

In accordance with § 54.1-2805 of the Code of Virginia, a student who is duly enrolled in a mortuary education program in the Commonwealth and who is not registered with the board as a funeral intern may assist in embalming in a funeral service establishment provided the following requirements are met:

- 1. The funeral establishment holds a current, unrestricted license issued by the board;
- 2.The funeral establishment and funeral service licensee or embalmer providing student supervision meet the accreditation standards of the American Board of Funeral Service Education and the Commission on Accreditation for off-campus embalming instruction;
- 3. Students shall receive instruction and shall observe embalming of a dead human body prior to assisting with an embalming in a funeral service establishment and shall assist with embalming in conjunction with an embalming laboratory course;
- 4. A funeral service licensee or embalmer may supervise up to three students under his immediate supervision, which shall mean the supervisor is physically and continuously present in the preparation room with the students to supervise each task to be performed;
- 5. A funeral service establishment shall include on the form granting permission to embalm information disclosing that the establishment is a training facility for mortuary education students and that a student may be assisting the licensee with embalming; and
- 6. The embalming report shall include the names of students assisting with an embalming and shall be signed by the supervisor.

Article 2. Licensure of Funeral Establishments

§ 54.1-2811. Facility requirements

A funeral service establishment shall contain a preparation room equipped with a tile, cement or other waterproof floor, proper drainage and ventilation, the necessary instruments and supplies for the preparation and embalming of dead human bodies for burial, transportation or other disposition, and separate restroom facilities.

A funeral service establishment having more than one location at which it performs funeral services shall not be required to maintain more than one preparation room.

The Board may adopt regulations and classifications to prescribe proper drainage and ventilation and necessary instruments and supplies in preparation rooms and separate restroom facilities.

Part VII. Standards for Embalming and Refrigeration

18VAC65-20-540. Preparation room requirements.

A. Every funeral service establishment at which embalming of dead human bodies is performed shall have at least one room used exclusively for embalming or preparation of the body.

- B. The following are required of the preparation room or rooms:
 - 1. The walls shall extend floor to ceiling;
 - 2. The floor and wall surfaces shall be of a material or covered by a material impervious to water; and
 - 3. The material shall extend from wall to wall with all joints tight and sanitary.
- C. All functions connected with embalming shall be performed within the preparation room.

18VAC65-20-570. Condition of preparation room.

- A. The preparation room or rooms shall be kept in a clean and sanitary condition at all times, subject to inspection.
- B. Inventories of embalming and preparation materials shall be stored in a container and in a manner that makes them impervious to water and protects them from contamination.
- C. Any items or supplies not directly used in an embalming procedure shall not be stored in the preparation room.

18VAC65-20-580. Preparation room equipment.

The preparation room or rooms shall be equipped with:

- 1. A ventilation system which operates and is appropriate to the size and function of the room;
- 2. Running hot and cold water;
- 3. Flush or slop sink connected with public sewer or with septic tank where no public sewer is available;
- 4. Metal, fiberglass, or porcelain morgue table;
- 5. Covered waste container;
- 6. Instruments and apparatus for the embalming process;
- 7. A means or method for the sterilization or disinfection of reusable instruments by chemical bath or soak; autoclave (steam); or ultraviolet light;
- 8. Disinfectants and antiseptic solutions;
- 9. Clean gowns or aprons, preferably impervious to water;
- 10. Rubber gloves for each embalmer, intern, or student using the room;
- 11. An electric aspirator or hydroaspirator equipped with a vacuum breaker;
- 12. An eye wash station that is readily accessible; and
- 13. A standard first aid kit, that is immediately accessible, either in the preparation room or outside the door to the preparation room.
