Discussion: Dr. Rodammer appeared before the Committee in person in accordance with a Notice of Informal Conference dated September 13, 2017, to inquire into allegations that he may have violated certain laws and regulations governing optometry practice in Virginia. DECISION

Case No. 177701:

Ms. Blount read the Findings of Fact and Conclusions of Law made by the Committee. Ms. Blount also reported that the Committee voted to have 6 of the 26 hours of continuing education ("CE") Dr. Allouche completed in 2016 applied to the CE deficit for 2015, and to require Dr. Allouche to provide verification to the Board that he has completed 10 hours of CE in optometry by January 1, 2018, for the remaining CE deficit for 2015.

Upon a motion by Dr. Linas and duly seconded by Dr. Goldberg, the Committee voted to accept the Findings of Fact and Conclusions of Law and decision as read by Ms. Blount.
