**\*\*\*If you wish to make an Oral Public Comment during the public hearing, you must follow the instructions below:**

- Oral public comment will be received during the public hearing from those persons who have submitted an email to [patricia.morrison@doli.virginia.gov](mailto:patricia.morrison@doli.virginia.gov) no later than **5:00 PM** on **November 4, 2020**, indicating that they wish to offer oral comment. Comments may be offered by these individuals when their name is announced by Ms. Morrison. Oral comments must be restricted to 5 minutes each.
- When logging onto WebEx each person **must provide their full name** during the registration process upon entering the meeting. Do not use the default username, as it is imperative that the meeting organizer be able to determine who is in attendance based on their registration name. Failure to follow these specific registration instructions will restrict your ability to participate with oral remarks.
- If you wish to make an oral comment and will be utilizing the “audio conference only” option to witness the hearing, you must provide the phone number you will be calling in from in your email to Ms. Morrison so that the administrator will know whom to unmute at the appropriate time.
