Ms. Moss opened the floor to any additions or corrections regarding the draft minutes from the July 8, 2024, Supporting Data Subgroup Meeting. Hearing no additions or corrections, the minutes were approved as presented.

### **Discussion**

Healthcare Workforce Data Center Survey Questions: The subgroup reviewed the current questions to determine how to obtain the information needed for the study. Dr. Shobo presented options to add a maximum of three to four questions to the current survey or to conduct a separate, more detailed survey. The group agreed that adding questions to the current survey was the most efficient way to obtain the needed information.

Additional survey questions were discussed, including animal types, practice scope and setting, educational background, practice radius and travel time, as well as using current data for full-time equivalents and locales to more precisely identify shortage areas. The same questions may be used for veterinary technicians and will be discussed at the upcoming LVT Scope subgroup meeting.

ACTION ITEM: Dr. Shobo will draft additional questions for the subgroup's consideration to include in the next survey.

ACTION ITEM: Dr. Burke will review the American Veterinary Medical Association and American Association of Bovine Practitioner surveys and VVMA's survey questions to consider for additional HWDC questions.

The subgroup agreed on the format for shared files for Supporting Data and other subgroups.

ACTION ITEM: Ms. Moss will share the link all the documents once uploaded.
