Best Practices for Zoom Meetings

1- Disconnect VPN as ZOOM works better and faster without VPN (only use VPN if you require access to VPN resources during the meeting)

2 - Close any other applications in the background you don't need for your meeting.

3 - Connect your computer to your internet router by network cable and not wireless, if you have a cable and can be near your router.

4 – Keep your microphone or telephone on mute unless you are talking.
