Regarding File Number 2009-00527, Harkirat Singh, Mr. De León reviewed the record of the Informal Fact-Finding Conference, which consisted of the application file, transcripts and exhibits and the summary and concurred with the recommendation of the presiding Board member. Mr. De León recommends the Board accept the Summary of the Informal Fact Finding Conference, which cites the following violation of the Board's regulations; 18VAC10-20-700.A.

Ms. Perkins informed the Section that Mr.Singh had no prior violations. Mr. De León recommends that the Board accept the recommended sanctions as contained in the Summary of the Informal Fact Finding Conference: \$500.00 and license probation of one year. During that probation, any infraction of the Board's regulations will result in the imposition of license suspension.

A letter from Mr. Awni was provided to the Section members stating that he felt his degree in architecture should be approved as a related science, coupled with his years of experience, he should be approved to take the PE exam.

Regarding File Number 2009-03357, Muhammad Awni, Mr. De León reviewed the record of the Informal Fact-Finding Conference, which consisted of the application file, transcripts and exhibits and the summary and concurred with the recommendation of the presiding Board member. Mr. De León recommends the Board accept the Summary of the Informal Fact Finding Conference, that Mr. Awni's application be approved for the FE exam under 18VAC10-20-190.5. and that he apply for the PE under 18VAC10-20-210.5 after successfully completing the FE exam.

Regarding File Number 2009-02293, Brendan Thomas Lawrence, Mr. De León reviewed the Consent Order as seen and agreed to by Mr. Lawrence. Mr. De León concurred with the recommendation of the presiding Board member. Mr. De León recommends the Board accept the Consent Order which cites the following violation of the Board's regulations: 18VAC10-20-20.A. For this violation, Mr. Lawrence agrees to the following monetary penalty: \$150.00 in Board costs. In addition,

Regarding File Number 2009-02653, Travis John Keys, Mr. Harris reviewed the Consent Order as seen and agreed to by Mr. Keys. Mr. Harris concurred with the recommendation of the presiding Board member. Mr. Harris recommends the Board accept the Consent Order which cites the following violations of the Board's regulations: 18VAC10-20-750.B (Count 1) and 18VAC10-20-750.C (Count 2). For these violations, Mr. Keys agrees to the following monetary penalty: \$250.00 for the violation contained in Count 1; no penalty for the violation contained in Count 2; and Board costs in the amount of \$150.00, for a total of \$400.00.

As the presiding Board member, Mr. De León was not present during the presentation or discussion.

Ms. Nosbisch gave a brief report on the 2009 NCEES NE Zone Meeting and read a letter from NCEES Executive Director Jerry Carter, thanking the Board for their efforts.

Discussion of NCEES Topics

Ms. Nosbisch informed the Section of the 2009 NCEES Engineering Award winners. Virginia Tech Charles E. Via Jr. Department of Civil and Environmental Engineering was awarded \$7,500 for their Land Development Design Initiative submission. Ms. Nosbisch read an email from Section Member Bif Johnson on his participation in the NCEES Award presentation to Virginia Tech.

Ms. Nosbisch informed the Section of a letter received from the West Virginia Board of Registration for Professional Engineers, announcing that their Board President Joe Timms, is under consideration for the position of NCEES President-Elect.

Ms. Nosbisch informed the Section of the FE and PE exam results from 2001 through 2008. The results had been obtained at the request of the National Society of Professional Engineers.

Ms. Nosbisch presented the Section response to an email received from Jerry Carter, NCEES Executive Director regarding the Certified Energy Manager stamp. The section determined they had no jurisdiction over the matter, but would take action if necessary.

Discussion of JMU ISAT Curriculum

Mr. De León stated that the Section would need all members present to proceed with discussion, and added that the presentation from faculty offered the Section a better understanding of the program. It was determined that the Section would take the information under advisement and discuss at the next Section meeting scheduled for August 5, 2009.

Other Business

Steven Jack, of the Attorney General's office, and Section members discussed the application review process. The discussion centered on whether or not the Board could conduct personal interviews to be included in the application review process. Mr. Jack informed the Section that the interviews could not be confidential; however, could be conducted as part of an IFF.

Ms. Nosbisch informed the Section about recent concerns regarding the use of LEED designation. There is no license required as a prerequisite for taking the LEED test, and after passing, the LEED designation can be used after the person's name. This may be confusing to the public as the designation does not take the place of licensure.

Ms. Nosbisch informed the Section that a motion was needed to select a funded delegate to attend the 2009 NCEES Annual Meeting. Mr. De León moved to have Ms. Nosbisch be the funded delegate. Mr. Harris seconded the motion which was unanimously approved by members: De León and Harris.
