NATIONAL ORGANIZATION PARTICIPATION COMMITTEE OF THE APELSCIDLA BOARD MEETING MINUTES

Mr. Holt, Chair, called the meeting to order at 11:00 a.m.

Approval of Agenda

Call to Order

Mr. Combs moved to approve the agenda. Ms. Stiles seconded the motion which was unanimously approved by members: Boyd, Combs, Holt, Scherzer and Stiles.

There were no public comments.

Public Comment Period

Ms. Nosbisch provided 2011 APELSCIDLA travel expenses to NCEES, NCARB, CLARB and NCIDQ conferences and meetings, for the Committee to review.

Discussion on the Importance of Board Participation in National Organizations

Mr. Dixon informed the Committee that the agency was issued a directive from Governor McDonnell's Chief of Staff, to reduce out-of-state travel. In lieu of this, all out-of-state travel must be approved by the Secretary of Commerce & Trade and all travel requests must have a justification statement explaining the value and mission of the travel. Mr. Dixon suggested the Committee review the scheduled meetings and conferences for the national organizations, and determine which would be most valuable to the Board's mission. Mr. Dixon stated that although DPOR is a non-general fund agency, the agency will follow the directive, showing a good faith effort.

Discussion was held on how to determine what was 'mission critical' to the Board and the individual professions, with regards to national meetings and how the board should proceed with requesting travel deemed as such. The Committee agreed to prepare justification statements specifically for each national organization, expressing the importance of representation and participation by the APELSCIDLA Board.

Discussion was held on travel to meetings that was completely funded by an organization. Ms. Nosbisch explained that often the agency paid extra expenses that the organization might not cover (parking, baggage fees, etc.) Ms. Nosbisch suggested including language in the justification stating that any extra expenses incurred by a board member on funded travel, will be paid by the board member, but this measure would be reviewed by the Finance Department to ensure we are not in violation of any policy, procedure or regulation governing travel. Thus no expense to the agency.

Mr. Boyd suggested increased participation by board members on national committees, etc. would help in that, travel expenses of committee participants are typically covered by the organization. In turn, this would increase representation of Virginia by board members. Mr. Scherzer stated that participation by Virginia board members could aid in convincing organizations to hold meetings and conferences in Virginia, therefore helping the economy.

The Committee agreed by consensus to continue to request travel authorization to appropriate meetings, with the knowledge that it may not be approved. Mr. Holt asked that all committee members provide a justification statement to Ms. Nosbisch by February 16, 2012. The statements will be presented at the March 20, 2012, APELSCIDLA Board meeting.
