# ARCHITECTS, LANDSCAPE ARCHITECTS & CERTIFIED INTERIOR DESIGNERS SECTION MEETING

#### **MINUTES**

Mr. Scherzer, Chair, called the meeting to order at 12:06 p.m.

Call to Order

Mr. Boynton moved to approve the agenda. Ms. Stiles seconded the motion which was unanimously approved by members: Boynton, Crowther, Good, Scherzer, Snetter, Stiles and Wilson.

Approval of Agenda

There was no public comment.

Public Comment Period

Ms. Snetter provided an update on the recent NCARB Member Board Chairs/Member Board Executives Conference, held in Indianapolis, IN, October 30-November 2. Ms. Snetter reported on the discussions of overhauling IDP and the proposed changes to the BEA and BEFA. She further stated that there has been a proposal by NAAB to combine design sections 4 and 5 of the ARE, and reduce the number of questions from 50 to 40. NCARB is looking at this proposal.

Mr. Armstrong discussed licensure through non-accredited paths and stated that 17 states do not require a NAAB accredited degree. He informed the Section members that NCARB has been considering alternative means to licensure, and have surveyed the member boards on several of these, as the current non-accredited paths are lengthy and expensive. Discussions on new ideas were held at the MBC/MBE conference in Indianapolis. Mr. Armstrong reported that attendees agreed a NAAB accredited degree is the preferred avenue, but are considering using IDP as the metric in lieu of the current committee review, dossier review and education evaluation for BEA candidates. Mr. Armstrong stated that the information will be sent to the member boards to discuss and the Board of Directors will review responses at their April meeting. A proposal will be voted on at the NCARB Annual meeting in June. Mr. Scherzer inquired as to whether the proposals would weaken the NAAB programs. Mr. Armstrong answered that the NAAB path is the preferred and most straightforward path to licensure. He also discussed the BEFA.

Mr. Armstrong informed the Section members that the new ARE is anticipated for late 2016 and installation of a public member on the Board of Directors is being considered.

Ms. Nosbisch reported that CLARB was taking nominations for Board of Director and committee service and asked Board members to submit nominations by January 9 if interested.

Ms. Nosbisch reported that Ms. Wilson is the CIDQ delegate, and that there are three action items that need to be addressed on QNet. Ms. Wilson will address these items on behalf of the Certified Interior Designer Section.

Ms. Nosbisch informed the Section members that the landscape architect and Other Business certified interior designer sections needed to elect Section chairs.

Mr. Scherzer nominated Mr. Crowther to serve as Chair of the Landscape Architect Section. Mr. Boynton seconded the motion which was unanimously approved by members: Boynton, Crowther, Good, Scherzer, Snetter, Stiles and Wilson. Section members congratulated Mr. Crowther.

Ms. Stiles nominated Ms. Wilson to serve as Chair of the Certified Interior Designer Section. Mr. Boynton seconded the motion which was unanimously approved by members: Boynton, Crowther, Good, Scherzer, Snetter, Stiles and Wilson. Section members congratulated Ms. Wilson.
