The Board approved the resolution by consensus. Mr. Clayborne thanked Ms. Nosbisch, the staff, and the Board members. He stated that this Board has been very impactful. Ms. Nosbisch thanked Mr. Clayborne for his service and indicated she looked forward to working with him in his new role at AIA.

Ms. Langelotti moved to grant 'board member emeritus status' to Wiley V. Johnson, III. Mr. Stone seconded the motion which was unanimously approved by members: Allen, Boynton, Crowther, Dunlap, Kelly, Langelotti, Scherzer, Snetter, Stiles, Stone and Zmuda.

Mr. Roadcap provided handouts to the Board members including Code of Virginia §32.1-164, Guidance Memorandum and Policy 2015-01: Onsite Sewage Application Expectations and Requirements dated January 1, 2015. Request for Waiver to the Survey Requirement, and two survey plats. Mr. Roadcap stated he is working with onsite soil evaluators, professional engineers, contractors, and developers putting in sewage or wells in residences or large scale buildings. He stated the current policy is from 2015. The policy requires a survey plat in all cases, unless you request a waiver. The waivers are normally seen in southwest Virginia where there are large tracks of land and people cannot afford surveys. All applications must have an accuracy of three feet or less. The policy does not dictate how to do it; just that it has an accuracy of three feet or less. This policy is in the process of being updated. An advisory committee, which represents fifteen groups, will revise the policy. He stated there is one county where the local health department has a blanket waiver to the survey plat requirement, which allows the property owner to submit an application using GIS system using imagery. Mr. Dunlap inquired why Loudoun County has a blanket

waiver; this is deemed a violation of our regulations. Mr. Roadcap stated he shares the Board's concern. He stated that he has reached out to the Loudoun County Health Director, Dr. David Goodfriend. Mr. Roadcap stated that Dr. Goodfriend stated he has confidence in the GIS system. Most of Loudoun County has been surveyed, so the county does not enforce the plat requirement and it is locally known. Mr. Roadcap stated that with the competition of the private sector, he is hoping VDH will allow the private sector to do more work in the way of soil tests, site evaluations, etc. and VDH will just regulate and check on compliance. He is hopeful the private sector will increase work so there will be less waivers. Mr. Allen asked if there is a surveyor on the advisory board because one is needed. Mr. Roadcap stated he will contact Ms. Nosbisch for recommendations of land surveyors to serve on the committee. He stated that VDH wants feedback; they are committed to updating the policy to what it should be.

The Board agreed by consensus, that a letter should be drafted to Dr. Goodfriend its concerns regarding blanket waivers.

A copy of the Guidance Document sent to localities on June 14, 2016 will be sent to Mr. Roadcap for his review.

The Board recessed from 10:35 a.m. until 10:48 a.m.

Ms. Broz-Vaughan, Deputy Directory, Communication and Board Operations, provided an update on the 2017 General Assembly Session. She stated that during the short session, nearly 3,000 bills and resolutions were introduced, of which DPOR Administration was responsible for 49 bills for tracking. She stated that SB 1374, added a professional engineer to the Contractors Board, HB 2076 directed DEQ to adopt regulations adding Soil Scientist to the list of licensed professionals allowed to design certain elements of SMPs, HB 2477 initiated implementation of VDH privatization plan for evaluation and design, and SB 1577 required VDH to study the need for sampling small alternative systems. Photogrammerty Bills HB 2145 & SB 1572 were requested by Virginia Association of Surveyors, which was intended to close the "loophole" allowing unlicensed photogrammetry, but were opposed by local governments and the GIS community. Both bills were passed by indefinitely.

The Board stated that our regulations cannot overstep the statutes; and that it cannot dictate what nonregulants do. The Board asked staff to provide a guidance document to educate the community on altering/editing sealed drawings. The guidance document will be sent to all localities, associations, and regulants to make them aware what is acceptable. The guidance document will be placed on the agenda for the next Professional Engineers and Land Surveyor's meeting on August 16, 2017, and then to the Board at the September 14, 2017 meeting.

The Professional Engineers reviewed the Use of Seal email and letter from the American Institute of Architects Virginia at the Professional Engineers Regulatory Review Committee meeting on April 18, 2017. The Professional Engineers determined the item needed further discussion and requested it be placed on the agendas of the Professional Engineers and Land Surveyors (PE-LS) Section meeting and Regulatory Review Committee meeting on May 11, 2017. The Section determined that the questions were more of a liability and contractual issue than a regulatory issue. The Section agreed by consensus to forward this item to the Regulatory Review Committee meeting on May 11, 2017 and recommended no changes at this time. The Regulatory Review Committee concurred to make no changes to the regulatory language at this time. After review and discuss, the Board concurred that this is a contractual matter and no regulatory changes will be made at this time; however, AIA can propose language during public comment.

Use of Seal Letter

Ms. Nosbisch noted that in her email to AIA Virginia, she informed AIA Virginia that the proposed titles "architectural associate" and "design professional" are a violation of the Board's regulations. Architectural is a protected term and professional indicates licensed or certified in one of the APELSCIDLA professions. The Board agreed by consensus.

Ms. Alexander arrived to the meeting at 11:19 a.m.

Arrival of Board Member

The Professional Engineers and Land Surveyors discussed the letter and attachments from Hanover County at their meeting on February 15, 2017. It was noted that no one should be using sealed plans without permission. A draft response to the letter was presented at the March 14, 2017 Board meeting. After a long discussion, the Board determined by consensus to reply to Hanover County stating the Board agreed to delay the official response in order to conduct additional review to provide a detailed response to the specific questions posed as well as additional comments on other topics addressed. Ms. Nosbisch presented the draft response to Hanover County's request for guidance. After discussion, the Board determined that § 54.1-402.C applies to each of the questions. The Board concurred to have staff prepare a revised response to Hanover County.

The Board recessed from 12:05 p.m. until 12:20 p.m.

The Regulatory Review Committee asked staff to contact the Bureau of Capital Outlay Management (BCOM) to inquire if all professionals had to seal cover sheets. The Board reviewed the BCOM Director, Mike Coppa's reply, which indicated BCOM's intent is to follow the Board's regulations as written.

He stated that CPSM details may be causing some confusion. BCOM will try to clarify this requirement in the next update of the CPSM.

Ms. Nosbisch stated that in the past, Mr. Johnson reviewed and made determinations on the requests for waiver of continuing education. Mr. Stone moved to approve Mr. Boynton to review the requests for waiver of continuing education and provide an update at each Board meeting. Mr. Allen seconded the motion which was unanimously approved by members: Alexander, Allen, Boynton, Crowther, Dunlap, Kelly, Langelotti, Scherzer, Snetter, Stiles, Stone and Zmuda.

Ms. Nosbisch stated that two of the waivers were health related and one was unemployment related. The unemployment related waiver had requested a waiver once before. This was the first time a regulant had requested a second waiver. Mr. Boynton will make determinations on these requests and report back to the full Board in September.

Request for Waiver of Continuing Education

Mr. Boynton provided a brief update on the Regulatory Review Committee comprised of Ms. Langelotti, Ms. Stiles, Mr. Boynton, Mr. Scherzer and Mr. Zmuda. He stated that the Committee just met June 1, 2017, and the next Committee meeting is August 16, 2017. Mr. Boynton thanked the staff, the Committee members, and Board members for their input and for doing a great job. Ms. Nosbisch also thanked outside entities for their input.

Regulatory Review Committee Update

Ms. Nosbisch noted that the Stormwater Management Facilities email had been discussed at the Professional Engineers Regulatory Review, Committee meeting on April 18th and at the Professional Engineers and Land Surveyors Section meeting on May 11, 2017, and today at the Board meeting. The Department of Environmental Quality (DEQ) states that anyone who works for a Stormwater (SMW) or Erosion Control Program (ESC) must be certified to review plans and conduct inspections for construction land disturbing activities; however, they do not have to be licensed through DPOR. Someone who is licensed still must be certified. The Board reviewed the draft letter. Ms. Langelotti moved to approve the letter to Mr. Murray. Mr. Stone seconded the motion which was unanimously approved by members: Alexander, Allen, Boynton, Crowther, Dunlap, Kelly, Langelotti, Scherzer, Snetter, Stiles, Stone and Zmuda.

Stormwater
Management Facility

The Board reviewed Mr. Davy McDowell's, NCEES COO, email to Ms. Nosbisch regarding the exam complaint. Ms. Nosbisch stated that with the number of people who take exams, we have very few complaints. She also stated that NCEES is contracted with Pearson, not APELSCIDLA.

NCEES Updates

The Board reviewed the letter from Mr. Robert Grubbs, PE, requesting support to add a plumbing option to the Principles and Practice Mechanical Engineering discipline exam. Ms. Nosbisch explained there has to be a minimum number of jurisdictions interested in a new exam before NCEES explores the possibility of adding it to the list. A minimum number of exam takers is required to keep the exam in the offering. No action will be taken by the Board at this time.

Ms. Nosbisch stated the Northeast and Southern Zone Joint Interim meeting April 27-29, 2017 was well done and informative. The Professional Engineer and Land Surveyor Board members had debriefed at the previous Professional Engineer and Land Surveyor Section meeting. She is looking forwarded to Virginia hosting the Southern Zone Meeting in Charlottesville April 19-21, 2018. She is hopeful all Professional Engineer and Land Surveyor Board members will be able to participate.

Ms. Nosbisch stated there will be a resolution presented at the NCEES annual meeting for a one time zone summit for the 100th anniversary meeting.

Ms. Snetter, Mr. Boynton, and Ms. Nosbisch will be attending the Annual Business meeting June 21-24, 2017 and will provide a report at the September 14, 2017 meeting.

NCARB Updates

The 2017 CIDQ Annual meeting will be held in Alexandria, Virginia. Ms. Nosbisch indicated the Director gave verbal approval in support of both Board members and her attending the conference since Virginia is the host state.

CIDQ Updates

Ms. Sutton provided an update on CLARB; topics included: CLARB is focused on regulation review, the exam was updated in April, task analysis, believe in collaboration, the future of regulation, technology, changing demographics of all professions, worked with other associations and Federal Association of Regulatory Board (FARB), common sense regulation, and boards should work with jurisdiction chapters.

CLARB Updates

Ms. Sutton also discussed the public welfare research. This research was to define welfare as it relates to the practice of landscape architecture and establish tangible indicators of how the profession positively impacts public welfare. The three primary objects for the research was to incorporate the welfare aspects of practice in the Landscape Incorporate the welfare related aspects of practice in the Landscape Architect Registration Examination (L.A.R.E.); increase awareness and understanding of how landscape architects positively affect public welfare; and strengthen licensure laws to include welfare—related aspects of practice in the definition of landscape architecture. In summary, Landscape Architecture positively affects public welfare by: enhancing environmental sustainability; contributing to economic sustainability; promoting public health and well-being; building community; encouraging landscape awareness and stewardship; offering aesthetic and creative experiences; and enabling communities to function more effectively

Ms. Nosbisch will seek approval for Mr. Crowther to attend the CLARB Annual Meeting in September 2017.
