Ms. Stiles reported that the University of Tennessee in Knoxville has changed the name of their interior design school to Interior Architecture which is part of the School of Architecture. It was noted that James Madison University has done the same.

Architect Section Update

Ms. Nobsich reported that nearly 3,000 have taken the early test in the latest version of Architecture Registration Examination (ARE) allowing NCARB to set cut scores for all six divisions and make a couple of ARE 5.0 upgrades. NCARB Update

ARE 4.0 retires June 30, 2018. Anyone who has not completed ARE 4.0 by June 30, 2018, must complete ARE 5.0.

Ms. Nosbsich reported there are five new programs accepted into the IPAL initiative: Boston Architectural College (B.Arch), Florida International University (M.Arch), New York Institute of Technology (M.Arch), Southern Illinois University (M.Arch), and University of Massachusetts Amherst (M.Arch).

As part of NCARB's upcoming centennial celebration, they are asking each jurisdiction to complete a brief history of their board by the end of the year.

The AXP Direct Supervision requirements will be tabled until the December meeting.
