Mr. Allen, Section Chair, called the meeting to order at 9:34 a.m. Call to Order

Mr. Allen reviewed the emergency evacuation procedures. **Emergency Evacuation**

Ms. Anglin moved to approve the amended agenda. Mr. Zmuda seconded the motion which was unanimously approved by members: Allen, Anglin, McAden, and Zmuda.

There was no public comment.

(TCC) Land Surveyor Certificate Program. He stated that the 2007 program was originally approved under regulation 18VAC10-20-300.A.5. Mr. Cartwright provided information on TCC Land Surveying Career Studies Certificate. He stated that the certificate can be completed 100% online in one year, but normally takes two years because most students are working. Mr. Cecere stated that DOLI representatives communicate to the public that the TCC Land

instrument person (4000 hours). The APELSCIDLA Board does not recognize the surveyor technician/survey assistant category. After discussion, the Committee agreed by consensus that because the regulations have changed and been renumbered; the program is now approved under 18VAC10-20-300.A.6. It was noted that the program is equated to an apprenticeship program. The information will be presented at the Professional Engineers and Land Surveyors Section meeting on August 9, 2018 and the full Board on September 13, 2018.

The Committee reviewed the previous meeting minutes for the Virginia Surveyor Apprenticeship Standards. It was noted that Fairfax County Public Schools revised their 2018-19 Apprenticeship catalog. With the changes, DOLI now recognizes the Fairfax Land Surveyor Apprenticeship program for party chief (8000 hours); the APELSICDLA Board does not recognize this category. Mr. Cecere stated that the Virginia Surveyor Apprenticeship Standards will not be signed off by the Commissioner because it does not contain the 720 contact hours. He suggested the Committee require the sponsor to document hours in health and safety procedures (and other work processes) as required in the regulations. It was noted that registered DOLI apprenticeship programs are transferable to other states.

Land Surveyor Apprenticeship Program

Ms. Emerson and Mr. Cecere left the meeting at 11:38 a.m.

The Committee recessed from 11:47 a.m. until 12:23 p.m. Mr. Cartwright left the meeting at 12:23 p.m.

After discussion, the Committee agreed by consensus to revise the Virginia Surveyor Apprenticeship Standards to require employers to document 150 Related Technical Instruction (RTI) experience hours over five years on the job training/learning and work courses outside the classroom in order to obtain 720 hours which meets DOLI's recommended hours. Mr. Allen suggested the Photogrammetry 30-Hour Project now in the approved RTI curriculum be removed, thus leaving 150 RTI hours documented by the employers. The photogrammetry component would need to be satisfied elsewhere, perhaps through one of the universities offering on-line classes. The information will be presented at the Professional Engineers and Land Surveyors Section meeting on August 9, 2018 and the full Board on September 13, 2018.

The Committee reviewed the National Society of Professional Surveyors (NSPS) website and Certified Survey Technician (CST) information. Ms. Anglin moved that NSPS CST Level IV, with no other education presented, be awarded eight years of approved surveying experience and access to the Fundamentals Surveyor exam; falling under regulation 18VAC10-20-300.A.7. Mr. Zmuda seconded
