LAND SURVEYORS SECTION MEETING

MINUTES

The Land Surveyors Section of the Virginia Board for Architects, Professional Engineers, Land Surveyors, Certified Interior Designers and Landscape Architects (APELSCIDLA Board) met on August 20, 2008, at the Department of Professional and Occupational Regulation, 9960 Mayland Drive, Richmond, Virginia, with the following members present:

No representative was present from the Office of the Attorney General.

Ms. McIntyre, Chair, called the meeting to order at 9:00 a.m.

Call to Order

Mr. Stephenson moved to approve the agenda as amended. Mr. McAden seconded the motion which was unanimously approved by members: McAden, McIntyre, and Stephenson.

Approval of Agenda

Public Comment Period – No comments were made to the Section members.

Public Comment

Regarding File number 2008-02330, C. Phil Wagoner, the Section members reviewed the Consent Order as seen and agreed to by Mr. Wagoner. Mr. McAden moved to recommend that the Board accept the Consent Order which cites the following violations of the Board's regulations: 18 VAC 10-20-750.A (Count 1); and 18 VAC 10-20-750.C (Count 2). For these violations Mr. Wagoner agrees to pay Board costs in the amount of \$150.00. In addition, Mr. Wagoner agrees to the suspension of his license until such time as the North Carolina Board of Examiners for Engineers and Land Surveyors either reinstated his license or declares him eligible for reinstatement. Further, Mr. Wagoner agrees that once he becomes eligible for reinstatement by the NC Board and provides proper

documentation of such to the Virginia Board, Mr. Wagoner will then be eligible to reinstate his Virginia license. Mr. Wagoner agrees to pay any fees associated to the reinstatement of his license and to provide the Virginia Board with documentation of continuing education hours taken, if required by the Board at the time of reinstatement. Ms. McIntyre seconded the motion which was unanimously approved by members: McAden and McIntyre. Mr. Stephenson was not present during the discussion or vote.

Mr. Stephenson discussed several of the topics of interests that were discussed at the NCEES Annual Meeting which included the BS+30; the possibility of an engineer practice examination; computer based examinations; and the resolution written on the request for the division of the governance of land surveyors and professional engineers within NCEES. Mr. Stephenson also discussed the Colonial States Boards of Surveyor Registration meeting. He noted that states previously not included now want to be included in order to receive the photogrammetry examination. Mr. Stephenson stated that Alabama was voted in at the Colonial States meeting.

Report from NCEES Annual Meeting

Mr. Stephenson discussed the upcoming NCEES Zone meeting to be held in Norfolk, Virginia, which the Virginia Board will be hosting. The Section discussed with staff the responsibilities and the need for assistance in preparation for the meeting as well as assistance needed at the meeting.
