Dr. Avula called the meeting to order at 9:00am

United Way of Southwest Virginia – Mr. Travis Staton, President & CEO Mr. Staton provided information on his organization and services provided.

Washington County DSS – Ms. Kathy Johnson, Director

Ms. Johnson welcomed members to the region and shared information on some of the challenges faced by her agency.

People Incorporated Community Action Agency – Mr. Robert Goldsmith, President & CEO Mr. Goldsmith provided information on the services provided by his organization and noted the close partnership with the Department of Social Services.

Tommy Casteel, Western Region Director & William Boone, Board Member

Mr. Casteel provided an overview of the western region and noted its unique features. Mr. Boone spoke about the region's lack of resources and the impact on vulnerable citizens and on the agencies charged with serving them.

Comments from the Commissioner – Mr. Duke Storen

Commissioner Storen provided updates on activities on the federal level, including the uncertainty regarding TANF reauthorization, Family First implementation and the Child Abuse Prevention Treatment Act. On the state level, he discussed the roundtables on gun violence scheduled for July, adopting ALICE as a system for assessing cases, local workforce recruitment and retention (including a work force study) and a change in SNAP rules.

FOIA Update – Elle Malenke, Asst. Attorney General

Ms. Malenke provided a refresher session for Board members, including responding to requests for public records and open and closed meetings.

The Board recessed for a tour of Western Regional Office, followed by lunch.

Comment from Local Boards and Directors of Social Services

Ms. Lana Mullins, Director of Scott County DSS and Kristin Shumate, Director of Grayson DSS, provided comments.

Comment from the Virginia League of Social Service Executives – Andy Crawford, President In addition to addressing the Board on current League activities, Mr. Crawford also shared challenges specific to his agency and to those of the other directors in attendance. This included inadequate office space, low salaries and lack of flexibility and options to recruit and retain adequate staff levels.

After some discussion, Dr. Avula asked Mr. Boone to draft a letter on behalf of the Board to Governor Northam, noting the struggles by local departments to attract and retain qualified staff and requesting that resources be provided in his 2020 proposed budget. Mr. Boone will work with Mr. Crawford and present a draft letter for consideration at the August meeting.
