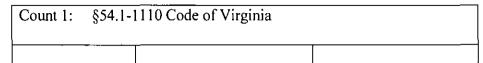

The new policy will require contractors to hold the Water Well/Pump (WWP) specialty to perform work inside a well or well casing. This particular clarification will prohibit plumbers form performing work on submersible pumps in drilled wells.
