



#### MINUTE NO. 2 - Hazardous Waste Management Regulations - Amendment 15A

Mr. Robert G. Wickline, Office of Waste Programs, presented proposed amendments to the Hazardous Waste Management Regulations to the Board. Mr. Wickline detailed the proposed amendments to the Board and explained that the amendments were a result of a comprehensive review of the incorporation of federal regulations accomplished in Amendment 14 and incorporation of additional federal text in replacement of analogous Virginia text (e.g., deleting the Virginia text describing the permitting process and replacing it with analogous text of federal regulations).
