Finding a quorum of the Board present, Mr. Aulbach, Chair, called Call to Order the meeting to order at 9:00 a.m.

Mr. Aulbach opened the floor for public comment. No members of Public Comment the public present requested to speak.

Period

Ms. Henshaw provided an updated preliminary timeline for Review of Timeline developing the draft Waterworks and Wastewater Works Operators Regulations and Onsite Sewage System Professionals Regulations. The timeline will be revised throughout the review process to ensure the Board's objectives are accomplished within required timeframes. Staff must file proposed text for Executive Branch Review by June 29, 2015. The Notice of Intended Regulatory Action (NOIRA) public comment period ends December 31, 2014. Staff may need to schedule another meeting in order for the Board to adopt final regulations by April 16, 2015.

Ms. Henshaw provided the Board with a revised draft of the Review Draft Waterworks and Wastewater Works Operators Regulations and Regulations Onsite Sewage System Professionals Regulations in accordance with the Board's comments from the September 16, 2014, Board meeting. The sections included:

- Standards of Conduct (Waterworks and Wastewater Works) Operators Regulations and Onsite Sewage System Professionals Regulations)
- Entry Requirements (Onsite Sewage System Professionals Regulations)

Ms. Henshaw also provided draft language of portions of the Waterworks and Wastewater Works Operators Regulations and Onsite Sewage System Professionals Regulations. The sections included:

- Entry Requirements Qualification Licensure for (Waterworks and Wastewater Works **Operators** Regulations)
- Renewal and CPE Requirements (Waterworks and Wastewater Works Operators Regulations)
- Entry Requirements Qualification for Licensure Onsite Soil Evaluator (Onsite Sewage System **Professionals** Regulations)

Ms. Henshaw also provided a handout indicating the Review Status of the draft regulations to ensure that all topic areas will be covered, and the status of review.

Mr. Aulbach suggested staff review the Waterworks and Wastewater Works Operator license requirements for other states, particularly those that border Virginia.

Staff advised that all changes made at this meeting will be incorporated into the draft document and provided at the next regulatory review Board meeting. Ms. Henshaw provided a handout on Classification Requirements for waterworks and wastewater works and requested guidance from the Board on any areas that may need amendment. Mr. Aulbach indicated that he would review the classification requirements as they apply to waterworks in light of the regulatory changes underway with VDH.

The Board discussed its plan for the next Board meeting. At the Plan Discussion next Board meeting, the Board will continue review of the draft Topics for Next Waterworks and Wastewater Works Operators Regulations and Meeting Onsite Sewage System Professionals Regulations. Sections that have not been reviewed to date include:

- Training Approval and Definitions (Waterworks and Wastewater Works Operators Regulations and Onsite Sewage System Professionals Regulations)
- Classification Requirements (Waterworks and Wastewater Works Operators Regulations)
- Renewal/CPE (Onsite Sewage System Professionals Regulations)

The Board discussed setting another meeting date for the Board to

Ergometrics/National Testing Network (E-NTN) will be the new examination vendor. The last day to take the exam administered by PSI is December 19, 2014. Candidates who have paid for the exam but who do not take the exam on or before December 19, 2014 will receive a refund of their exam fee from PSI. Staff will post a notice on the DPOR website indicating the new vendor.
