#### **Welcome and Introductions**

Claudia Lopez-Muñiz, Committee Vice-Chairperson, called the meeting to order at 10:30 a.m. A quorum was present. Committee members introduced themselves.

#### Approval of March 20, 2024, Meeting Minutes

Kate Hanger made a motion to approve the March 20, 2024, meeting minutes. Toni Zollicoffer seconded the motion. The motion passed unanimously.

#### **Virginia Department of Social Services Prevention Funding**

Nancy Fowler, Director, Office of Family Violence, Virginia Department of Social Services (VDSS), presented on Sexual and Domestic Violence Primary Prevention Funding. Nancy's presentation included information about the history and purpose of the fund and general information about funded projects (locations and the varied models used by programs).

#### **State Agency Funding Updates**

- Virginia Department of Criminal Justice Services (DCJS)
   Kristina Vadas presented on grant programs administered by DCJS. These grant programs include:
   VSGP competitive (federal VOCA); VSGP for SDV services (federal VOCA and state); VSTOP (federal);
   SASP (federal); ARPA (federal); VSDVVF (state), Victim/Witness (federal and state). Kristina explained that the recently passed state budget included additional funds for some of these grant programs. Kristina also shared when these grant programs' current subgrants start and end.
- Virginia Department of Health (VDH)
   Maria Altonen reported that VDH recently hosted the first in-person Rape Prevention and
   Education (RPE) grant recipient meeting since the pandemic. VDH is partnering with the Virginia
   Sexual and Domestic Violence Action Alliance (VSDVAA) to host four listening sessions intended to
   improve economic supports for victims. These listening sessions will occur June 11
   (Fredericksburg), June 26 (Newport News), July 12 (Wytheville), and July 17 (virtual). Information is
   attached to the minutes. VDH is working with "1 in 6" which focuses on men's experiences of
   sexual assault. VDH will host two all-day related trainings on June 13 and June 20.
- Virginia Department of Housing and Community Development
   Kike Oliver reported that their Homeless and Special Needs Housing Unit recently completed grant
   application reviews for their Virginia Homeless Solution Program. Award announcements will be
   made by the end of June.
- Virginia Department of Social Services
   Nancy Fowler presented on the varied grant programs administered by DCJS. These grant programs include the following: Domestic Violence Prevention and Services (supporting comprehensive DV services and DV Primary Prevention services); Domestic Violence Services for Underserved Populations; Sexual and Domestic Violence Programs ARPA grant; Vaccines Testing and Access to Mobile Health; Sexual and Domestic Violence Prevention grant; and SDV Prevention Training and Technical Assistance grant.

#### **Past Business**

- Virginia Sexual and Domestic Violence Program Professional Standards
   Amber Stanwix, Professional Standards Operations Coordinator with DCJS reported that the
   updated Professional Standards manual was approved by the Professional Standards Committee on
   April 8, 2024. The Professional Standards guidelines for procedures were also recently updated.
   DCJS will host informational session on the revised manual and guidelines on July 10 and July 17,
   2024. The next round of accreditation will start with agency assessments; the proceed of which will
   be open September 3-27, 2024.
- Virginia State Crime Commission Language Access Study Request

Prior to the meeting, the Crime Commission sent an email informing the committee that they are not able to include the Committee's Language Access study request as part of its studies for this year (SFY 2025). If the committee would like to make a similar request of the Crime Commission for state fiscal years 2026 or 2027, they should submit another letter with that request. The committee discussed the possibility of asking a college or university to conduct the survey or asking DCJS and the Courts to work on this issue. The VSDVAA will reconvene the work group that made the request to discuss next steps.

#### **New Business**

#### **Other Member Announcements**

Jonathan Iglesias with the VSDVAA reported that they are hosting an Economic Justice Summit
at Hampton University on June 27, 2024. They have a foundation grant that provides travel

#### **Public Comment**

In response to the earlier discussion about how to proceed with a language access study, Elieen Longenecker informed the committee that the Office of Executive Secretary is not staffed to run studies and therefore they have limited capacity for such work. Also, the language access work group did not hold public meetings the last time they came together. If courts, law enforcement, and probation are being discussed, it would be helpful to be a public meeting so the public can appear to address questions and provide information.

# DCJS Victims Services Team Grant Programs

## **State General Funds**

In the final SFY 2025 state budget, additional **general funds** were appropriated to support several projects:

- Sexual and Domestic Violence Agencies
  - Increase of @ \$2 million to \$4,568,114
- Victim Witness Programs
  - Increase of @ \$1.3 million to \$5,988,807
- Support for competitive victim services projects
  - \$1,250,000

# Victims of Crime Act (VOCA)

- Virginia's federal fiscal year 2024 VOCA appropriation is anticipated to be \$19,866,137, down from \$34,605,387 in FFY 2023.
- We anticipate a similar award in FFY 2025.
- Federal Crime Victims Fund balances remain concerningly low, but there are some efforts at the federal level to stabilize the fund.

# **DCJS VOCA-Supported Grants**

- Victims Services Grant Program (VSGP) Competitive
  - SFY 2025 12-month awards begin 7/1/24.
  - 32 awards totaling @ \$4,134,113 in VOCA and state general funds.
- VSGP for Sexual and Domestic Violence Agencies (non-competitive)
  - SFY 2025 12-month awards begin 7/1/24.
  - 55 awards totaling \$15,800,255 in VOCA and state general funds.
  - Awards restored to slightly-higher than SFY 2023 levels (combined with ARPA grant awards; pending CJSB approval).

## **DCJS VOCA-Supported Grants**

- Victim Witness Grant Program (VWGP)
  - SFY 2025 12-month awards begin 7/1/24.
  - 114 awards totaling \$19,237,848 in VOCA and state funds (general and special funds).
  - Awards restored to @ SFY 2023 levels (pending CJSB approval).

# Violence Against Women Act (VAWA)

- Funds administered by the Office on Violence Against Women.
- Federal fiscal year 2024 SASP and STOP anticipated funding amounts equal FFY 2023 levels:
  - SASP = \$79 million
  - STOP = \$255 million

# **DCJS VAWA-Supported Grants**

## Sexual Assault Services Program (SASP)

- SFY 2024 Special One-Time Funding Opportunity: 12-month awards ending June 30<sup>th</sup>.
- CY 2024: New grants began on 1/1/2024.

## VSTOP

- CY 2024: New 24-month grants began on 1/1/2024.
- Law enforcement, culturally-specific, and sexual assault-specific projects were eligible to receive an increase, and three new programs were awarded funding as a part of a competitive application process.

# Other Funding Sources

### ARPA VSGP Restoration Grants

- SFY 2025 12-month awards begin 7/1/24.
- 54 awards totaling \$3,365,679 in ARPA funds (pending CJSB approval).

## Virginia Sexual and Domestic Violence Victim Fund (VSDVVF)

- SFY 2025 12-month awards begin 7/1/24.
- 49 awards totaling \$2,258,803 in state general and special funds (pending CJSB approval).
