Goals: Share best practices related to the Virginia Ryan White Quality Improvement activities and discuss strategies to improve the QMAC infrastructure.

VDH Updates – Camellia Espinal, QM Specialist, and Tinika McIntosh-Amouzouvi, Lead HIV Care Services Analyst

- HRSA ADAP Performance Measures Update
 - Revised measures:
 - ADAP application determination
 - ADAP inappropriate antiretroviral regimen components resolved by ADAP
 - Introduces the following new measures:
 - Viral suppression for clients who receive ADAP services
 - Loss of ADAP Services due to failure to confirm eligibility
 - Timely payment of health insurance premiums
 - Enrollment in health care coverage (including Medicaid, Medicare Part D, and private health insurance)
- New Medication Access Model – planning for implementation of the new medication access model for uninsured client has begun. More details to come.
- Medicaid Unwinding – SEP Update: For individuals no longer eligible for Medicaid, a Special Enrollment Period (SEP) was established for Marketplace enrollment until July 31, 2024
 - Federal Marketplace extension through 11/30/2024
 - Virginia’s Insurance Marketplace extension to 09/30/2024
- Unified Eligibility Assessments (UEAs) – VDH will be sending letters to clients without a completed eligibility assessment in Provide Enterprise. Clients must complete an assessment with a RWHAP B subrecipient.
 - Assessment completion within the designated timeframe
 - VDH will be activating the Provide Enterprise eligibility function on 09/30/2024.
 - RWHAP B services will automatically suspend without valid assessments or eligibility end dates in the system.

Virginia Ryan White Cross-Parts Updates

- Part A
 - FAHASS – Service Navigation, latest focus has been on Brother-to-Brother events. Educating and increasing connection to care for men of color.
 - EVMS (to include Part C) – Ryan White abstract was accepted by National Ryan White Conference. Four QI projects are ongoing. Increase collaboration with internal medicine providers. Ghent Gives back event will be hosted in June.
 - Norfolk TGA just concluded a HRSA site visit

- Part C
 - VCU – Since February, restarted linkage to care program. Several staffing updates: 2 new CM supervisors, 2 MCMs and 1 new NMCM. 2600 at end of GY23. Has achieved 90% viral load suppression. Ongoing nutrition classes.
 - Mary Washington – Preparing for Part C site visit. In the process of applying for Part C and Prevention grant through CDC. Performance measures have improved. Pride event will be hosted at the medical facility to highlight LGBT support.
 - Carillion – Part C includes Oral Health and Psychosocial Services.
 - UVA – ID clinic and Ryan White Program continues to provide care and have achieved 93% viral load suppression rate. Patient needs initiatives reviewed.
 - CAHN – Provide ongoing outpatient care, continued with the Rapid Start program, working with Feed Me More to support client food insecurity, support groups. Wellness retreats will be hosted last in the year.
 - CAN – Continue to provide outpatient services. Managing a small grant from VDH to provide PrEP services. Hired two NMCMs recently to support/refer to MCM services. Upcoming events include a Black Community Summit. Recently provided discussion on nutrition and sexual health.
 - VCU/MAAETC – A lot of staffing changes. Onboarding personnel to support HIV and Aging Workgroup. Case Management Summit was held in February/March. Many ongoing

trainings held recently. Participating in the VDH led HIV and Aging pilot program. Added an additional Prevention training series by special request.

- Inova – Many staffing changes as well. EIS includes outreach and testing of MCM and Psychosocial support services. Part D is participating in WICY Title V meetings. Part F hired a new education manager in January. Testing and Outreach continues. Translation services are highly used across all funding programs. Participating in DC Black Pride Memorial weekend.

Open Questions and Parking Lot Wrap-up – Allison Green, VDH HCS Senior Advisor

- Issues for VDH to evaluate internally as highlighted by subrecipients during the meeting:
 - Eligibility errors and the need for additional communication
 - Misalignment of UEA requirements in Provide Enterprise and Case Management Standards
 - Timeframe for agencies to received UEA error reports
 - VACAC – the need for innovation to engage the younger population
