Ms. Nosbisch introduced Jack Fulton, Founder and CEO of International Championship Boxing. Mr. Fulton provided information on offering cage style mixed martial arts. He stated that the Nevada Athletic Commission unanimously approved the cage style mixed martial arts and that Mike Mazzouli, President of the Association of Boxing Commissions and Combative Sports, endorsed the use of the cage. He indicated some referees from Virginia were cage trained in Nevada.

Public Comment Period

Ms. Broz Vaughan stated that the Board is not an athletic commission. Under the Administrative Process Act, we don't have the ability to think out of the box. The regulations would have to be amended which is a three stage process which allows for discussion of merits, public participation, and to make sure everything is vetted. The Board will soon be starting regulatory review and it can be discussed, but the Board does not have the ability to approve it at this time.
