## **Comments from the Commissioner** – Mr. Duke Storen

Commissioner Storen thanked everyone for taking the time to be there and for their on-going service, interest, and investment in the system. He expressed his appreciation and thanked the providers, local departments of social services, community service boards, and stake-holder partners for their broad collaboration of work. He provided federal and state updates.

Mr. Boone acknowledged the three directors from southwest Virginia- Lana Mullins, Jennifer Lily, and Trevor Hensley.

Comment from the Public

**Emily Griffey** – Voices for Virginia's Children

Ms. Griffey encouraged the Board to keep child care subsidy on the radar to give it a brighter spotlight and do what they can to encourage the state agency and policy makers to take it seriously.

## Tawana Tucker – African American Assisted Living Facilities

Ms. Tucker spoke about individuals who suffer with paranoia and manic depression and making sure a displacement plan is in place.

#### **Comment from Local Boards and Directors of Social Services**

Lana Mullins, Director, Scott Co DSS, shared that her agency was one of the 25 that received additional funding for foster care services. She thanked the Commissioner for his support.

Comment from the Virginia League of Social Service Executives – Andy Crawford, President Mr. Crawford was not in attendance. His representative, Rick Verilla, provided updates on his behalf. He spoke about the Medicaid dashboard and thanked the Commissioner.

### Senate Bill 1326 (2019) – Tara Ragland

Ms. Ragland provided an overview of Senate Bill 1326, which was left in the Senate Rehabilitation and Social Services Committee. The Committee requested that the Board provide a report with recommendations regarding the regulation of room occupancy in assisted living facilities, in follow-up to Senate Bill 1326. Dr. Heck and Ms. Ali will assist Tara with drafting the report for the Board's consideration.
