Comments from the Commissioner – Duke Storen

Commissioner Storen thanked everyone for participating in the virtual board meeting. He welcomed new Board member, Jennifer Slack. Comment from the Virginia Community Action Partnership – Jim Schuyler, Director

Mr. Schuyler expressed his thanks to the department and local agencies. He thanked the Commissioner and the Community and Volunteer Services team for their collaborating network. Mr. Schuyler recognized Dr. Avula and his team, and their work with the CDC Foundation. He gave a snapshot of the COVID response by the community action network from March 2020 through September 2020. He also shared VACAP, along with VDSS, is assisting to provide training on risk management and business continuity plans, fundraising and fund development, strategic and crisis communications, and remote work innovations.
