### Purpose

Chapter 991 of the 2004 Acts of Assembly was enacted on July 1, 2004, repealing the authority of the Virginia Board of Education to regulate proprietary schools and granting it to the State Council of Higher Education for Virginia (SCHEV). SCHEV has always had oversight for private non-profit and out-of-state degree-granting institutions. 8 VAC 40-31 et. seq., which governs the certification of private and out-of-state postsecondary institutions to operate in Virginia, was finalized August, 2006 combining the previous regulations that governed the proprietary schools with the regulations that governed private and out-of-state institutions. Since that time, staff have identified several areas of consumer protection that were not included in the original regulations. Also, with the increasing use of technology in higher education, e.g. distance learning, it was determined that the current regulations failed to provide sufficient guidance to institutions using that modality.

The State Council of Higher Education for Virginia is granted explicit authority to promulgate regulations necessary to implement the provisions of § 23-276.3 of the Code of Virginia which states: "The State Council of Higher Education for Virginia shall adopt, pursuant to the Administrative Process Act (§ 2.2-4000 et seq.) such regulations as may be necessary to implement the provisions of this chapter. The Council's regulations shall include, but need not be limited to, (i) procedures by which a school may apply for Council approval to confer degrees in Virginia; (ii) measures designed to ensure that all postsecondary schools that are subject to the provisions of this chapter meet minimal academic standards; (iii) protections for students pursuing postsecondary education opportunities in schools subject to the provisions of this chapter; and (iv) information to assist persons who rely on postsecondary degrees, diplomas, and certificates in judging the competence of individuals."

#### Need

The regulations governing private and out-of-state postsecondary institutions are designed to ensure the certified schools meet minimal academic standards, provide protections to students pursuing postsecondary educational opportunities at these schools, and provide information to persons who rely on postsecondary degrees in judging the competence of individuals. Amending, modifying and deleting the current version of 8 VAC 40-31 et. seq. will ensure that the certified institutions continue to provide a valuable service to the citizens of the Commonwealth of Virginia.

#### Substance

The proposed revisions to the current regulations include: clarification of certain defined terms; addition of certain terms; modifications to advertising/marketing requirements; clarification of the exemption for religious institutions, as well as schools, programs, degrees, diplomas and certificates exempt from Council action; clarification of action taken against a previously exempted institution whose authorization to grant or confer degrees is revoked; modifications to the application for certification criteria; enhancement of faculty academic attainment requirements; clarification of student records maintenance expectations; clarification of financial reporting requirements; addition of telecommunication program standards; revision of tuition refund policy; addition of leave of absence provisions; addition of guidance for institutions that require internship, externships and production work as part of the institution's educational requirement; addition of equipment and facilities standards; clarification of the use of the terms "college" and "university"; modification of the change of ownership procedure; addition of specific actions that may result in the suspension or revocation of an institution's certificate to operate; modifications of the procedures for conducting fact-finding conferences and hearing, in accordance to the APA; revision of the fee structure to ensure fairness, and to provide for sufficient revenue to support the

costs of POPE operations and a proportionate share of SCHEV's operations (POPE is self-supporting and must collect adequate revenue to support its mandated and approved activities and operations); addition of a specific teach-out procedure in the event of a school closure; and the deletion of the Freedom of Information Act information, as all documents retained by SCHEV are subject to the Freedom of Information Act.

#### **Alternatives**

SCHEV could continue using the existing regulations, however, consumers (students) will have limited protections against postsecondary institutions operating in Virginia. Certain areas of clarification, though not all, in the proposed regulations could be addressed by the creation of guidance documents. However, the guidance documents themselves would not have desired clarity without profound changes in regulations.

SCHEV will form a Regulatory Advisory Panel. The RAP will consist of administrators of the regulated institutions and a representative of the Virginia Career College Association.

# Family impact
