The purpose of the proposed action is to develop and adopt a general permit regulation to comply with the provisions of 40 CFR Parts 9, 122, 123, and 412 as published in the Federal Register Volume 68, No. 29, dated February 12, 2003. The general permit regulation will govern the authorization to manage pollutants from concentrated animal feeding operations, including storage and land application of animal waste.

The State Water Control Board has the authority to administer the federal National Pollution Discharge Elimination System program within the Commonwealth, and as such, the program is called the Virginia Pollution Discharge Elimination System (VPDES). Operations that meet the Federal definition of Concentrated Animal Feeding Operation (CAFO) found in 40 CFR 122.23n must seek coverage under a NPDES permit. This action will result in the promulgation of a VPDES general permit that will allow those operations to obtain this type of permit. CAFOs are currently regulated in Virginia under the Virginia Pollution Abatement (VPA) permit regulation 9 VAC 25-32, the VPA General Permit Regulation for CAFOs 9 VAC 25-192, and the VPA General Permit Regulation for Poultry Waste Management 9 VAC 25-630. Affected operations currently permitted under these regulations will be required to be permitted under this new VPDES general permit regulation

### Family Impact Statement

Because CAFOs are currently regulated in Virginia, and this action serves only to transfer the regulatory mechanism governing select CAFOs from the VPA regulatory system to the VPDES regulatory system, it is not expected to have significant impact on family or family stability.
