In summary, no VWP permit is required for the construction and maintenance of agricultural or silvicultural ponds or impoundments that meet specific criteria in the Virginia Soil and Water Conservation Board code § 10.0-604 et seq. In order to be consistent with the statute, Sections 50, 60, 130, and 220 of the VWP regulation need to be revised.

Additionally, several processing forms used by the VWP program were updated, and thus, the Forms section of the regulation was also revised to note the correct form versions.

The amendments were adopted by the State Water Control Board at its meeting on October 16-17, 2008.
