The amendment to the existing VPDES permit regulation authorizes, if the permit applicant so elects, the newspaper publication of an abbreviated public notice for minor industrial VPDES permits, containing a link to the full public notice on the Department of Environmental Quality's website. Current law requires the publication of a full public notice in a newspaper once a week for two successive weeks for all major and minor permitted facilities. The cost of the newspaper public notices is paid for by the owner of the permitted facility.

This final agency action is based on 2018 legislation of the General Assembly which amended and reenacted § 62.1-44.16 of the Code of Virginia, relating to discharge of industrial wastes; notice of application.
