proper conduct of its examinations, the proper conduct of the home inspectors certified by the Board, the implementation of exemptions from certifications requirements, and the proper discharge of its duties.

The current regulations are the first to be promulgated under statutory authority granted by the 2001 Session of the Virginia General Assembly and have been in effect since July 1, 2003 without amendment. The passing of four years since initial promulgation and the Board's experience with the current regulations lead the Board to conclude that a general review as well as consideration of continuing professional education (CPE) provisions is appropriate at this time.

Substance

The Board proposes to conduct a general review and, if appropriate, propose amendments to correct any deficiencies found. The Board is concerned that its entry requirements, especially its experience requirements, may need amendments to assure only properly qualified individuals receive a certification. The standards of practice will be similarly reviewed to identify any new or existing hazards to the public that require amendments to correct. Finally, the Board will consider adding a regulation provision requiring continuing professional education (CPE) to assure competent practice and the resulting public protection.
