The Virginia Employment Commission (VEC) seeks to amend Section 20, First level appeals, of 16 VAC 5-80, Adjudication, to clarify current practices and reflect Agency modernizations including a shift toward electronic forms and online portals. This action will add language to subsection A(1) allowing first level appeals to be filed by an electronic format prescribed by the commission.

The impetus for the regulatory change is an internal staff review of procedures to best meet the needs of Virginians seeking VEC services. The regulations regarding methods for filing appeals have not been updated for many years, and this regulatory change is necessary to modernize agency procedures, increase accessibility for Virginians, and expedite agency services. There is no mandate as defined above.
