The Virginia Waste Management Board's Solid Waste Management Facility Permit Action Fee and Annual Fee Regulation, 9 VAC 20-90-10 et seq., establishes the fees for new permits and modifications to permits for solid or regulated medical waste management facilities. -The Virginia General Assembly provided new requirements in the Code of Virginia for annual permit fees during the legislative session of 2004. The regulation has been modified to include the new requirements from the Code and to establish appropriate administrative procedures for implementation of the new annual fee requirements.

The Virginia Waste Management Board adopted regulations entitled Solid Waste Management Permit Action Fees and Annual Fees as final regulations on June 18, 2004.

Family impact
