# Notice of Intended Regulatory Action (NOIRA) Agency Background Document

### Purpose

Virginia Code §19.2-310.2 dictates that the Department shall maintain a data bank of those individuals required to provide a DNA sample pursuant to Code. These new regulations establish the process for the Department of Forensic Science to allow law enforcement to obtain information from the data bank and the procedures for verifying the requestor's identity and authority as outlined in Virginia Code §19.2-310.5. It also requires the Department to specify the positions which will require regular access to the data bank as a necessary function of their job.

Virginia Code § 19.2-310.5 states that the Department of Forensic Science "shall adopt regulations governing (i) the methods of obtaining information from the data bank in accordance with this section and (ii) procedures for verification of the identity and authority of the requestor." (See 2005 Virginia Acts C. 868).

The proposed regulations are necessary to fulfill the General Assembly's mandate.

Need

Written comments must include the name and address of the commenter. In order to be considered, comments must be received by the last day of the public comment period.

A public meeting will not be held, unless in compliance with the Department's Public Participation Guidelines, which state "if prior to the close of the 30-day comment period on the NOIRA, the Board receives a request for a public hearing on the proposed regulation from (i) the Governor or (ii) 25 or more persons, such a hearing shall be held."

## Participatory approach
