The Boards of Nursing and Medicine have amended applicable regulatory requirements pursuant to legislative change. These changes reduce required practice from five years to three prior to autonomous practice.

[Chapter 404 of the 2024 Acts of Assembly](#) reduced the requirement for autonomous practice from five years to three. The Board of Nursing’s regulatory requirements are currently in conflict with statutory law and must be changed.
