There is also the addition of an inactive licensure category for both Nursing Home Administrators and Assisted Living Facility Administrators (NHAs and ALFAs). This category will expand the regulatory pathways available within the Board and allow someone who is not currently practicing to maintain their licensure for a reduced fee so they can return to the field quickly should they desire. There is a small direct benefit related to the new inactive licensure fee, however the extent of that benefit will be unknown since we are not sure how many licensees who would have otherwise let their license expire would become inactive.
