The purpose of this action is to amend the board's regulation governing approval of new alcoholic beverage products to implement changes suggested by a recent periodic review. The action is intended to 1) consolidate the container and labeling requirements for wine and beer approval from four sections to two and standardize the requirements for each, 2) remove vague and unenforceable language relating to "lewd or indecent" labels on wine or beer and 3) allow for combining previously approved items into a gift package.

"(d)etermine the nature, form and capacity of all containers used for holding alcoholic beverages to be kept or sold under this title, and prescribe the form and content of all labels and seals to be placed thereon...."

The proposed regulatory action is necessary to streamline and consolidate the label and container requirements for wine and beer and to remove vague and unenforceable language pertaining to lewd or indecent labels.

It is anticipated that Chapter 40 will be amended to consolidate existing provisions for approval of wine and beer labels and containers, eliminate antiquated, unenforceable language, and provide for previously approved individual items to be offered in a combination pack.

There is no viable alternative to affect the proposed changes. The use of Circular Letters and other guidance documents in lieu of regulatory changes was considered, but such instruments do not have the force of law as formally promulgated regulations. Some of the proposals lessen the burden on the regulated community.

A public hearing will not be held following the publication of the proposed stage of this regulatory action.

No comments were made concerning this regulation.

In keeping with Executive Order 14 (2010), the following observations are made. This proposal is necessary to promote the general health, safety and welfare of the public and is easily understandable. There is a continued need to have conditions and restrictions on the labels and containers of alcoholic beverages.

The proposal is easily understandable and does not conflict with other state or federal laws or regulations. This regulation was last amended in 2004. A desire to eliminate redundant requirements for wine and beer labels and containers led to this proposal. Additionally, the proposals remove vague and unenforceable language relating to label approval.
