Commenter	Comment	Agency response

The regulation is amended to be in compliance with Chapter 155 of HB 1842 from the 2017 General Assembly Session that increased the proof for grain alcohol sold in government stores from 101 to 151. The amendment has sunset provision and will expire on July 1, 2022.
