Currently, the regulations governing consent settlements require board approval. Such approval was feasible under the administration of a full-time board; however, as the agency transitions into an Authority, the board will operate on a part-time basis. Maintaining the requirement of board approval for all consent settlements will become burdensome to a part-time board and will significantly impair the consent settlement process.

The proposed regulation changes will amend Subsection A so that the chief hearing officer can extend an offer of consent settlement without approval from the board. The changes further amend Subsection B so that a settlement is not conditioned upon approval of the board. Subsection C is amended in that it extends the time in which the licensee may return the properly executed consent settlement. Subsection D is amended so that the board does not have to approve acceptance of consent settlement agreement. Lastly, Subsection E is amended so that it is no longer required that the board review all proposed

consent settlements and removes the requirement of approval by the board in order for a consent settlement to be final.

On January 10, 2018, the Alcoholic Beverage Control Board adopted an amendment to 3-VAC5-10 PROCEDURAL RULES FOR THE CONDUCT OF HEARINGS BEFORE THE BOARD AND ITS HEARING OFFICERS, amending the existing regulation 3-VAC5-10-150 Consent Settlement to proceed under the fast track regulatory process.

Section 4.1-101 of the Code of Virginia (Code) establishes the Department of Alcoholic Beverage Control (ABC Board.)

Section 4.1-103 of the Code enumerates the powers of the Board which includes the authority to adopt regulations and to do all acts necessary or advisable to carry out the purposes of Title 4.1 of the Code (ABC Act). Section 4.1-103(7) states the Board may delegate or assign any duty or task to be performed by the Authority to any officer or employee of the Authority. Section 4.1-103(24) permits the Board to promulgate regulations in accordance with the Administrative Process Act and Section 4.1-111.

Section 4.1-111 (A) provides the Board with the authority to adopt reasonable regulations which it deems reasonable to carry out the provisions of the ABC Act and to amend or repeal such regulations.

The purpose of this regulation change is to accommodate the new part-time board. As the Department of Alcoholic Beverage Control transitions into an Authority, it was necessary to make amendments to the regulations dealing with procedural rules so as to make the process more efficient and to not overburden

the new part-time board. Approvals that were once subject to board approval have been delegated to the chief hearing officer.

The amendments are expected to be noncontroversial because they are in the licensee's favor and simplify the consent settlement process.

Approvals that were once subject to board approval have been delegated to the chief hearing officer thereby accommodating the new part-time board while not hampering the process for licensees.

The primary advantage to this regulation amendment is that it will make the process for consent settlements more efficient because it allows the board to delegate the responsibility of approving consent settlements instead of having to wait for board approval which could delay the process as the board will meet much less frequently under the Authority. There are no disadvantages to the agency or the Commonwealth. Pertinent matters to the regulated community, government officials, and the public are that consent settlements will not always have oversight from the board; however, they will be delegated to chief hearing officer who may have more intimate knowledge of the case and the significance of the settlement terms.
