Currently, the regulations governing informal conferences reference an old code section. Additionally, the regulation includes language stating that inasmuch as the Code of Virginia continues to require that license suspension or revocation be preceded by a formal hearing, the informal conference may not be used for purposes of agreement fixing a period of suspension or license revocation although an offer of settlement shall be received for board consideration.

The proposed changes will amend the regulation so that it cites the current section of the Code of Virginia, and removes the language referencing the Code of Virginia continuing to require that license suspension or revocation be preceded by a formal hearing and removes the language referencing an offer of settlement. The proposed amendment also provides that any initial decision will include a summary of the informal conference.

On January 10, 2018, the Alcoholic Beverage Control Board adopted an amendment to 3-VAC5-10 PROCEDURAL RULES FOR THE CONDUCT OF HEARINGS BEFORE THE BOARD AND ITS HEARING OFFICERS, amending the existing regulation 3-VAC5-10-220 Informal Conferences to proceed under the fast track regulatory process.

Section 4.1-101 of the Code of Virginia (Code) establishes the Department of Alcoholic Beverage Control (ABC Board.)

Section 4.1-103 of the Code enumerates the powers of the Board which includes the authority to adopt regulations and to do all acts necessary or advisable to carry out the purposes of Title 4.1 of the Code (ABC Act). Section 4.1-103(24) permits the Board to promulgate regulations in accordance with the Administrative Process Act and Section 4.1-111.

Section 4.1-111 (A) provides the Board with the authority to adopt reasonable regulations which it deems reasonable to carry out the provisions of the ABC Act and to amend or repeal such regulations.
