House Bill 390 and Senate Bill 389 of the 2020 General Assembly session (the "Bill") reorganized all alcoholic beverage control licenses pursuant to the three-tier structure and license privileges, consolidated many licenses with common privileges, aligned license fee amounts with enforcement demands, and standardized quantity limits on alcohol samples. Enactment Clause 9 of the Bill directed the Board of Directors of the Virginia Alcoholic Beverage Control Authority to promulgate regulations to implement the provisions of the act. The Board's

initial adoption of regulations necessary to implement the provisions of this act shall be exempt from the Administrative Process Act (§ 2.2-4000 et seq. of the Code of Virginia), except that the Board shall provide an opportunity for public comment on the regulations prior to adoption. House Bill 1845 of the 2021 General Assembly session delayed the effective date of the Bill from July 1, 2021 to January 1, 2022.

Enactment Clause 9 of House Bill 390 and Senate Bill 389 of the General Assembly session directed the Board of Directors of the Virginia Alcoholic Beverage Control Authority (the Board) to promulgate regulations to implement the provisions of the act. The Board's initial adoption of regulations necessary to implement the provisions of this act shall be exempt from the Administrative Process Act (§ 2.2-4000 et seq. of the Code of Virginia), except that the Board shall provide an opportunity for public comment on the regulations prior to adoption.
