## Summary

In order to reduce an accumulated surplus in the budget of the Board of Pharmacy, a one-time reduction in renewal fees has been adopted. The renewal fee for pharmacists and physicians selling controlled substances will be reduced for the annual renewal from \$90 to \$50, and for pharmacy technicians, the renewal fee will be reduced from \$25 to \$15. Fees for inactive licensure (which are approximately one-half the active renewal fee) are reduced correspondingly.

Renewal fees for facilities are also being reduced from \$270 to \$210 (pharmacies, physician permit, nonrestricted manufacturers, wholesale distributors, warehousers) and for restricted manufacturers or medical equipment suppliers from \$180 to \$140. The percentage of reduction is less for facilities because the Board must continue to conduct routine inspections every two years at a cost of approximately \$350 to \$400 per inspection. The facility renewal fees must offset those costs, as well of expenditures related to the licensing and discipline work of the Board and the Department.

On September 27, 2006, the Board of Pharmacy amended 18VAC110-20-10 et seq., Regulations Governing the Practice of Pharmacy, 18VAC110-30-10 et seq., Regulations for Practitioners of the Healing Arts to Sell Controlled Substances, and 18VAC110-50-10 et seq., Regulations Governing Wholesale Distributors, Manufacturers and Warehousers for a one-time reduction in renewal fees and inactive fees for the renewal cycle ending December 31, 2006.
