In an action that became effective March 5, 2020, the Board eliminated the requirement in section 60 for hours of supervised practice to qualify for licensure as a licensed baccalaureate social worker. The requirement in section 51 for an applicant to submit documentation of supervised practice was overlooked in that action. Therefore, subsection B 3 is deleted for consistency.

On March 13, 2020, the Board of Social Work amended 18VAC140-20, Regulations Governing the Practice of Social Work.

The language in section 51 B 3 is deleted to correct an oversight in the action previously promulgated to repeal the requirements for hours of supervised practice for licensure as a LBSW. Since this is a housekeeping action, there is not controversial and is appropriate for fast-track.

Regulations are promulgated under the general authority of Chapter 24 of Title 54.1 of the Code of Virginia. Section 54.1-2400, which provides the Board of Social Work the authority to promulgate regulations to administer the regulatory system:

§ 54.1-2400. General powers and duties of health regulatory boards.

The general powers and duties of health regulatory boards shall be:

1. To establish the qualifications for registration, certification, licensure or the issuance of a multistate licensure privilege in accordance with the applicable law which are necessary to ensure competence and integrity to engage in the regulated professions.

2. To examine or cause to be examined applicants for certification or licensure. Unless otherwise required by law, examinations shall be administered in writing or shall be a demonstration of manual skills.
3. To register, certify, license or issue a multistate licensure privilege to qualified applicants as practitioners of the particular profession or professions regulated by such board.
4. To establish schedules for renewals of registration, certification, licensure, and the issuance of a multistate licensure privilege.
5. To levy and collect fees for application processing, examination, registration, certification or licensure or the issuance of a multistate licensure privilege and renewal that are sufficient to cover all expenses for the administration and operation of the Department of Health Professions, the Board of Health Professions and the health regulatory boards.
6. To promulgate regulations in accordance with the Administrative Process Act (§ 2.2-4000 et seq.) that are reasonable and necessary to administer effectively the regulatory system, which shall include provisions for the satisfaction of board-required continuing education for individuals registered, certified, licensed, or issued a multistate licensure privilege by a health regulatory board through delivery of health care services, without compensation, to low-income individuals receiving health services through a local health department or a free clinic organized in whole or primarily for the delivery of those health services. Such regulations shall not conflict with the purposes and intent of this chapter or of Chapter 1 (§ 54.1-100 et seq.) and Chapter 25 (§ 54.1-2500 et seq.).

Purpose

The proposed amendment is a correction of an oversight from a previous action. The requirements for licensure by examination for an LBSW include completion of a degree in social work and passage of a board-approved examination, so public health and safety are adequately protected without the reference to a regulatory section that has been repealed.

In an action that became effective March 5, 2020, the Board eliminated the requirement in section 60 for hours of supervised practice to qualify for licensure as a licensed baccalaureate social worker. The requirement in section 51 for an applicant to submit documentation of supervised practice was overlooked in that action. Therefore, subsection B 3 is deleted for consistency.

There are no alternatives. The Registrar was unable to correct the oversight by publication of an errata.
