This action amends 18VAC140-20-171 to remove a limitation that agency subordinates be used only for disciplinary matters, consistent with the passage of <u>Ch. 191 of the 2023 Acts of Assembly</u>. This change will allow boards that use agency subordinates to employ those agency subordinates to hear credentials, or applications, cases as well as disciplinary cases.

The impetus for this action is the passage of <u>Ch. 191 of the 2023 Acts of Assembly</u>, which statutory amendment allows regulatory boards of the Department of Health Professions to use agency subordinates to hear credentials cases at the informal fact-finding level.
