Purpose

The regulation was adopted November 27, 1985, and contains outdated language, particularly with respect to brucellosis eradication efforts and animal disease traceability. The regulation serves a very important purpose in prescribing the rules governing the operation of livestock markets. Because of the number of animals congregated at livestock markets and buying stations in the state, there is a substantial risk of disease transmission.

Changes are needed to this regulation for two reasons. First, due to language describing the tests and procedures employed for Brucellosis testing in 1985, the regulation is no longer valid. The regulation requires that all cows two years of age or older that are sold at a market be tested for brucellosis; this "first-point testing" was stopped in Virginia ten years ago by direction from the State Veterinarian. However, unfortunately the associated identification of these cows also stopped. Thus, the second reason for changing this regulation is to provide a means for ensuring that Virginia cattle are traceable in the event of a disease outbreak; this also has advantages in domestic and international marketing of these traceable cattle, addresses demands from other countries where animal disease traceability is routine, and will be necessary to ensure that Virginia is compliant with USDA requirements for animal disease traceability.

Legal basis

This regulation is promulgated pursuant to Code of Virginia as detailed below (parts of each section provided in quotes):

- §3.2-6001 **Protection of livestock and poultry -** "The Commissioner, the Board, the State Veterinarian and all other veterinarians within the Commonwealth shall use their best efforts to protect livestock and poultry from contagious and infectious disease."
- §3.2-6002 Contagious and infectious diseases; prevention and eradication "The State Veterinarian shall take such measures as may be necessary to prevent the spread of and eradicate contagious and infectious livestock and poultry diseases. The Board may adopt regulations as may be necessary to effectuate the purposes of this article. The Board and Commissioner are also authorized to make the regulations adopted under this article conform, insofar as practicable, to those regulations adopted under federal statutes governing animal health."
- §3.2-6012 Duty of operators of stockyards and poultry slaughter facilities "Any person who operates a stockyard, poultry slaughter facility, or any other premises where livestock or poultry are repeatedly assembled: (i) shall maintain such premises in a sanitary condition as directed by the State Veterinarian; (ii) shall obey all orders or regulations adopted pursuant to this chapter as to handling livestock or poultry that nay be affected with contagious or infectious disease, or that have been exposed to contagious and infectious disease; and (iii) shall clean and disinfect such premises or vehicles used in connection therewith, or any part thereof, when ordered to do so by the State Veterinarian or his representative."
- §3.2-6016 Altering disease control identification of livestock or poultry "It shall be
 unlawful for any person to, unless in accordance with regulations adopted pursuant to this article,
 alter, deface, change from one animal to another, mutilate, substitute, remove, misrepresent, or
 otherwise interfere with any tag, brand, tattoo, mark, or other identification adopted or used by
 any county, the Commissioner, the Board, the U.S. Department of Agriculture, or any other state
 for the identification of any animal in the Commonwealth for the purpose of controlling or
 eradicating disease."

As stated in §3.2-6002, "the Board may adopt regulations as may be necessary to effectuate the purposes of this article." The authority under state law is both mandatory and discretionary.

Under federal law, the authority to implement some of the requirements of this regulation is expected to be mandatory. The United States Department of Agriculture (USDA) Animal and Plant Health Inspection Service (APHIS) is planning on adding a new section to title 9 of the *Code of Federal Regulations* (9 CFR) which would require that livestock moving interstate be officially identified and accompanied by an interstate certificate of veterinary inspection (ICVI) or other documentation, with some exemptions. This proposed rule is planned to be published in April, 2011, with an effective date to follow.

Need

The proposed regulatory action is essential to protect the health, safety, and welfare of citizens for the same reason that the following statement may be found in the *Code of Virginia*: "The State Veterinarian shall take such measures as may be necessary to prevent the spread of and eradicate contagious and infectious livestock and poultry diseases (§3.2-6002). That is, for the express purpose of protecting the health of livestock in poultry. This is necessary for three reasons: (1) to directly enhance the health of the animals; (2) to promote the financial interests of the livestock producers (disease can cause significant losses to the producer, through death loss, decreased production, and reduction of market options); and (3) to enhance human health in cases of zoonotic (shared human and animal pathogens) disease transmission.

In addition to the above stated need and benefit to the health, safety, and welfare of citizens, this regulation is also needed to comply with the expected federal rule requiring that livestock be identified and be able to be traced in the event of a disease event.

Substance

The existing regulation will be changed to remove the specific language requiring the brucellosis testing of all cows offered for sale at the livestock markets. The requirement for permanent identification that was associated with that testing will need to remain in the regulation.

Alternatives

Please describe all viable alternatives to the proposed regulatory action that have been or will be considered to meet the essential purpose of the action. An alternative to the proposed regulatory action would be to request that all livestock market operators voluntarily officially and permanently identify cattle offered for sale in their markets. However, it is fully realized that there is a time and financial cost to applying permanent identification, and as long as some markets do not provide this service, there is the potential for an inequitable situation. In order to fulfill the statutory mandate that the "State Veterinarian shall take such measures as may be necessary to prevent the spread of and eradicate contagious and infectious livestock and poultry diseases" (§3.2-6002), it is necessary to have effective animal disease traceability.
