## **Purpose**

The proposed action seeks to establish regulations for the harvest and sale of American ginseng plants and parts by (i) allowing only the harvest of wild ginseng that is five years of age or older; (ii) establishing an annual harvest season from September 1 to December 31; (iii) requiring harvesters to plant ginseng fruit near the harvested plant; and (iv) establishing a ginseng selling season of September 1 to March 31 for green ginseng, and September 15 to March 31 for dry ginseng. This action is necessary to ensure the long-term survival of American ginseng in the Commonwealth and its continued viability as a profitable export.

### **Legal basis**

The Virginia Department of Agriculture and Consumer Services (VDACS) administers the provisions of the Endangered Plant and Insect Species Act (Act), § 3.2-1000 et seq., Code of Virginia (Code). § 3.2-1002(A) of the Code authorizes the Board of Agriculture and Consumer Services (Board) to adopt regulations including the listing of threatened or endangered plant and insect species, their taking, quotas, seasons, buying, selling, possessing, monitoring of movement, investigating, or protecting. This authority is discretionary.

§ 3.2-1007 of the Code provides that (i) the indigenous plant *Panax quinquefolius* L., commonly referred to as ginseng, is declared a threatened plant species when it occurs in the wild; (ii) persons buying or accepting wild ginseng or parts thereof for resale are required to be licensed by the Commissioner of VDACS and to acquire wild ginseng or parts thereof only in accordance with the provisions of the Act and related regulations; (iii) the wild ginseng harvest season shall be set by the Board of Agriculture and Consumer Services; and (iv) the taking of wild ginseng by any person, other than from his own land, outside of the harvest season, constitutes a violation of the Act.

§ 3.2-1008 of the Code requires persons wishing to export any quantity of ginseng out of the Commonwealth, whether wild or artificially propagated, to obtain an export certificate from VDACS. To obtain the export certificate, individuals must keep accurate records of the year of harvest and county of origin of the ginseng. In the case of dealers, they must keep accurate records of purchases, quantity purchased, whether the ginseng was wild or cultivated, county of origin, and the name of the seller. The records must be made available to the Commissioner of VDACS for inspection.

#### Need

In September 2010, the U.S. Fish and Wildlife Service (USFWS) notified VDACS that current practices governing the harvest and sale of ginseng in Virginia were inadequate to ensure the continued survival of the species. USFWS encouraged VDACS to pursue regulatory changes that would allow USFWS to continue to find that exports of wild American ginseng roots from Virginia are not detrimental to the survival of the species in the wild. If USFWS is unable to continue to make such finding, it may not allow the export of ginseng.

VDACS believes that the establishment of the science-based requirements contemplated in the proposed action will effectively address USFWS concerns regarding the long-term survival of American ginseng in the Commonwealth, while at the same time facilitating the continued commercial trade of this valuable plant export. VDACS is not aware of any potential issues that may need to be addressed as the regulation is developed.

#### Substance

The proposed action seeks to:

- 1) Allow only the harvest of wild ginseng which is five years of age or older.
- 2) Establish an annual harvest season from September 1 December 31 of each year for wild ginseng.
- 3) Require harvesters to plant ginseng fruit and seeds near the harvested plant from which it was produced.

4) Establish a ginseng buying season of September 1 – January 14 for green ginseng and September 15 – March 31 for dry ginseng.

#### **Alternatives**

The proposed action is the most practical, science-based approach that will effectively address USFWS concerns regarding the long-term survival of American ginseng in the Commonwealth while at the same time providing for its continued viability as a profitable export. No other viable alternative exists that will accomplish these objectives in a cost-effective manner.

# **Family impact**

The proposed action will have a positive impact on the institution of family and family instability by ensuring that the harvest of ginseng continues to be a commercially viable activity for Virginians engaged in this activity. Harvesters dig wild ginseng roots from natural forested habitat. The roots are normally dried and sold to licensed ginseng dealers. Dealers pay harvesters anywhere from \$250 to \$900 per pound for ginseng roots, depending on market conditions. This supplemental cash inflow is particularly beneficial to the residents of the areas where ginseng is harvested, many of whom refer to it as "Christmas money" because of the time of the year when the sales occur. During Fiscal Year 2010, VDACS staff inspected and certified 4,072 pounds of wild ginseng and 116 pounds of artificially propagated ginseng harvested from 39 Virginia counties with an estimated value of \$1,427,500.
