Section 3.2-703 of the Code of Virginia (Code) authorizes the Commissioner of the Department of Agriculture and Consumer Services (VDACS) to extend or reduce areas currently regulated for plant pests. Pursuant to this authority, the Commissioner has expanded the *Virginia Imported Fire Ant Quarantine for Enforcement of the Virginia Pest Law, 2* VAC 5-315 *et seq.,* to include the counties of Charlotte, Dinwiddie, Halifax, Lunenburg, and Sussex due to an increase in imported fire ant populations in these localities. Expansion of the regulated area became necessary after surveys conducted by VDACS indicated that imported fire ant populations had become established in these localities and eradication was no longer feasible.

Once established, the imported fire ant has the potential to spread to non-infested areas, either through natural means or through the movement of infested articles (artificial spread). The quarantine is intended to prevent the artificial spread of this pest. Under the terms of the quarantine, articles at risk for transporting imported fire ants (regulated articles) are prohibited from moving out of the quarantined area unless certified as free of imported fire ant. Imported fire ant free certification can be obtained through (i) inspections conducted by VDACS or (ii) compliance agreements between businesses and VDACS, which stipulate steps businesses must take to ensure regulated articles transported out of the quarantine are free of imported fire ants.

Section 3.2-703 of the Code requires that, prior to extension or reduction of a quarantine, the Commissioner must provide notice in a newspaper with general circulation in the affected area. Legal notices were published in local newspapers in Charlotte, Dinwiddie, Halifax, Lunenburg, and Sussex counties during the week of November 28 - December 2, 2022.

Mandate and Impetus

Expansion of the regulated area became necessary after recent surveys conducted by VDACS indicated that imported fire ant populations had become established in the counties of Charlotte, Dinwiddie, Halifax, Lunenburg, and Sussex and eradication was no longer feasible. Expansion of the quarantined area is intended to prevent the artificial spread of the imported fire ant from infested areas of the Commonwealth to non-infested areas, thereby reducing the impact of the imported fire ant on citizens and businesses and protecting the public's health and welfare in non-infested areas.

The imported fire ant quarantine was established in 2009 after eradication efforts were unsuccessful and restricts the movement of regulated articles capable of moving the imported fire ant to uninfested areas of Virginia. The initial quarantine included much of the Tidewater area. In 2017 and 2018, survey data indicated a widespread population in south central Virginia, and the regulated area was expanded in 2019, adding five new counties and two independent cities to the quarantined area.

Statement of Final Agency Action

Pursuant to Section 3.2-703 of the Code, the Commissioner of Agriculture and Consumer Services expanded the regulated area of the Virginia Imported Fire Ant Quarantine for Enforcement of the Virginia Pest Law on December 5, 2022, in an effort to prevent further artificial spread of the imported fire ant and protect Virginia's agricultural and natural resources.
