The regulation needed a critical review because it was determined that certain current requirements were not effective. The addition of new speed measurement devices also necessitated a title and content change for these instructors. An Advisory Committee assisted with this review. Current recertification requirements do nothing to enhance instructor capability. An approach allowing certified law enforcement academies to formulate their own program for recertification of instructors is believed to be more effective. This program will be subject to scrutiny during academy recertification. A change from radar instructor to speed measurement instructor is being made because of the addition of new speed measurement devices for use by law enforcement.

Alternatives

Please describe all viable alternatives to the proposed regulatory action that have been or will be considered to meet the essential purpose of the action.

Consideration was given to exploring possible deregulation in this area. However, this was not recommended nor condoned by the Advisory Committee. The Committee chose to recommend an individual academy approach to determine if or what methods may be appropriate for statewide use at a later time.

Family impact

The impact on the family is indirect. Quality instruction in any area of law enforcement training is desired and requiring instructors to meet minimum requirements for recertification in order to deliver quality training is the goal. Good instructors tend to produce better trained officers who may have an impact on a family.

Periodic review

This NOIRA serves as both a periodic review and announcement of intent to amend the regulation. Instructor certification training is necessary for public safety instructors to have the opportunity to acquire additional information and skills related to the delivery of training in a competent manner. Such competency is essential to public safety since the personnel who

receive training from certified instructors are law enforcement officers, jailors, court security officers, process service officers, dispatchers and correctional officers of the Department of Corrections, Division of Institutions.
